# **TIPS and TIDBITS**

What is the standard lifetime of the following types of records or objects before they seriously deteriorate?

- 1. Newspaper clippings (A few years)
- 2. Computer printer paper (5-10 years)
- 3. Modern book paper (50 years if properly housed)
- 4. Bond, high rag content papers (50 years or more)
- 5. Magnetic (press down) page photo albums (4 years)
- 6. Color photographs (20 years)
- 7. Slides (15 years or more)
- 8. Polaroid, instant-print photographs (2 years)
- 9. Scrapbooks made with rubber cement (10-15 years)
- 10. Video cassette (10-20 years)
- 11. Audio cassette (10 years)

#### Preparing for a research trip:

- Pedigree charts for those being researched.
- Family Group Sheets for those being researched.
- Research records of what you have already done, so you don't waste your time on repeating something you've already tried.
- A "surname file" with copies of other relevant information on the people you are targeting for this visit.
- Pencils even if you are a devoted pen user, make sure to take pencils because Mid-Continent does not permit use of pens (due to the possibility of a stray mark on a record).
- Paper and plenty of copies of any forms you use for abstractions. If you hit a "goldmine" of information, you want to be ready!
- A magnifying glass is often handy and can help decipher when transcribing a document which can't be copied, or determining if the document is really the one you want to have copied.
- Your computer, with your most up-to-date data on the target families, and any other computer tools you use, i.e., forms for abstractions, spreadsheets for logging research, etc. It's a good idea to have the power cord and an extension cord too, in case you get on a roll, you don't want to run out of battery power!
- Plenty of nickels and dimes for making copies.
