May Meeting: The May 10 meeting was held at the Nevada Library with 17 persons present. Dorothy Foster conducted the meeting in Neoma Foreman's absence. Joanne Saathoff, Norma Fancher, and Rick Williams were welcomed as new members (see their personal information below). It was agreed that a genealogy seminar would be held again next year and planning could begin earlier. Dorothy Foster reported that because of expansion at the Mid-Missouri Bank building in El Dorado Springs, the Society would no longer meet at that location. She will contact other venues in El Dorado Springs. She distributed copies of literature that the Society had received in quantity (a copy of each having been posted on the bulletinboard at the Library).

"Records at Risk" was the video program. It discussed ways to preserve our individual research records. The program also stressed the need to let family members know the importance of your genealogy research and what should be done with your materials, so years and years of research would not be tossed out by unknowing family members. In discussion following the video, a show of hands indicated that none present had published his/her research, and everyone was urged to place a copy of their research in our local library for both preservation and the benefit of other researchers. This copy could be updated every few years as more research is completed. A few members had distributed copies of their research to other family members. Members were also encouraged to keep a diary or journal to pass down to future generations. Members were asked to consider what records the Society can help preserve and what additional records or materials are needed in the Genealogy Room. A handout on preserving personal research was distributed.

Genealogy Room Volunteers: Susan McBeth, Library Director, has inquired about having a volunteer in the Genealogy Room on Saturdays because several researchers are frequently there at that time and need help. Would YOU be willing to help with this? Perhaps we have 3 or 4 members who would be willing to regularly help just *one* Saturday a month. The Library is open from 10 a.m. – 2 p.m. on Saturdays. If you can help on Saturdays in the Genealogy Room, please contact Dorothy Foster or Neoma Foreman. Things are being done in the Genealogy Room to make it more independently usable by researchers. We will have an orientation session for volunteers to acquaint them with assisting researchers. *Please call Neoma or Dorothy today and say you can help!*

The June 14 Meeting will be a field trip for members to the Mid-Continent Genealogy Library in Independence, MO. This is the largest genealogy library in our region, and this will be an opportunity to research people/places/documents you don't have access to in this area. *Genealogy from the Heartland*, available in the Nevada Library Genealogy Room, lists many of the materials available at Mid-Continent, if you would like to check it prior to the field trip. TIPS and TIDBITS

World War I Military Service Cards Database

A new database is now available at www.sos.state.mo.us/ww1/ This World War I Military Service Cards database provides information about **Missouri** men and women who served both stateside and overseas from 1917 to 1919. The database searches abstracts of 145,000 service cards for the **United States Army** and **Marines**, as well as digitized images of 18,500 **United States Navy** service cards.

In April 1917, the United States entered World War I. Nearly 750,000 Missouri men registered for the draft. Over 156,000 served in all branches of the armed forces, and more than 10,000 were wounded or killed in action. Missouri contributed military personnel to all branches of service during the war. Original draft record information for Missouri veterans is available on microfilm at the St. Louis Public Library; and original draft record information is also available through the National Archives and Records Administration (http://www.nara.gov).

In the event that errors and discrepancies occur, Missouri State Archives staff will consult the original service card. If the error or discrepancy is the result of a typographical data entry mistake, the database will be amended to reflect the accurate information. If the error or discrepancy is part of the original service card though, staff will not amend the database information. That information was abstracted from an original archival record and cannot be altered.

For information about military personnel in wars following World War I, researchers should contact the National Personnel Records Center, 9700 Page Boulevard, St. Louis, MO 65132. The National

Personnel Records Center will not accept requests for military personnel records or information from them by e-mail at this time.

A fire at the National Personnel Records Center in 1973 destroyed many military records. An estimated 80% of the U.S. Army personnel records created from 1912 to 1963 were destroyed. The fire did not damage U.S. Navy and U.S. Marine Corps personnel files. (Information taken from the Missouri Archives website.)

If you do not use a computer in your genealogy research and would like to have ancestors searched in this Missouri-only database, please give a list of names to the society and searches will be made for you.

PERSI

The Periodical Source Index (PERSI) is the world's largest and most widely used index of articles from genealogy and history periodicals. Created by the Allen County Public Library in Ft. Wayne, Indiana, this annually updated database has become the largest of its kind and is renowned as a key to superior genealogical research. This is an amazing amount of quality information published in periodicals every year, and PERSI brings it to light. With over 1.7 million entries, it is fully indexed and instantly searchable, searching generally or specifically. PERSI can be searched online at: Ancestry.com (subscription). A search for "Vernon County Missouri" brings up 305 listings at this time. You will be able to search PERSI at Mid-Continent (if you don't currently have access to it). The Vernon County Historical Society's quarterly publication, Bushwhacker Musings, is indexed on PERSI.
