Bill Denman Guest Speaker at November 8 Meeting in Nevada

Bill Denman of Denman Land Title Company, Nevada, presented the program at our November 8 meeting, speaking about the work of a title company in Missouri as it relates to genealogy. He shared that a 1920 Vernon Co plat map was being prepared and would soon be available online in addition to the 1903 plat map which is at www.denmantitle.com He explained that to search for a school in the 1903 Plat Map, first conduct a search with the name of the school as the last name; if not found, then insert the name of the school as the first name. It was suggested that cemeteries be included in future plat maps, if possible. When asked about also placing an older plat map online, he indicated that was certainly something which could be done. He also reported that Denman Land Title would undertake a project of putting local obituaries online. This is all very exciting news for genealogists! An interesting question & answer session was conducted, and Mr. Denman was thanked for his time in meeting with us.
