January 10, 2004 Nevada Meeting

Neoma Foreman conducted the meeting at which she tabled the old business of obtaining the Vernon County probate files, microfilm rolls #107-154, which are needed in the Genealogy Room.

The Cass County and Bates County history books which the Society recently purchased for the Genealogy Room were presented for viewing. Labels were placed on the inside cover indicating they were donations from the Society. A copy of "From Dumfries to Drywood: The Story of James McKill and His Descendants" which is a published genealogy by Joe Yokley whose ancestors came to Vernon County in 1846 was also donated to the library. This is a very interesting work as it includes copies of civil war records and transcriptions of letters from that timeperiod. Additionally it contains information on McKill Chapel and Cemetery, which are located in Harrison Township.

It was also reported that the bulletin board had been installed in the Nevada Library Genealogy Room, and that a workshop on Internet for Beginners had been donducted. Another internet course will be scheduled and also a session on working with digital photographs.

It was reported that Jewel Cooey's new e-mail address is <u>cooey@tri-lakes.net</u> and that she will have an open house on Jan 25 from 2-4 p.m.

Dorothy Foster reported that the collection of Best Choice UPC codes for cash redemption continues to go well, and another \$30 bonus certificate has been received. A sign has been placed in the Genealogy Room inviting researchers to bring their labels and place them in a container on the file cabinet.

Neoma reported that she had presented a program for the Joplin Genealogical Society, focusing on what our society is doing, where we are at and where we're going, and what resources we have available here. She was thanked by our members for so ably representing our Society to a neighboring group.

Microfilming Courthouse Records

Neoma reported that she and Dorothy had attended a grant workshop at the Courthouse pertaining to

microfilming the old Vernon County records which are presently stored in the Courthouse basement. The cost of microfilming the records will be covered by the grant and the Society will spearhead the volunteers needed to prepare the documents for filming. This is an excellent opportunity for the Society to be involved "hands-on" in preservation of valuable county records. Vickie Erwin, Circuit Court Clerk, will be at our March meeting and explain the microfilming project and what will need to be done in preparing the records for microfilming. This is a joint project with the Missouri State Archives, the County, and the Society.

Acquisition of Wilma Lathrop's Genealogical Library

It was reported that Wilma Lathrop has indicated that she is planning to sell her genealogy materials and equipment because of health reasons. Wilma was asked if she would please allow the Society to have first option on the collection, and she indicated she would do so. Wilma has created many indexes and databases of records and newspapers from this region which makes her collection of immense value to the Society. The Society gave Neoma authority to begin discussions with Wilma regarding acquisition of her entire collection including all indexes, databases, and publication rights. It is hoped that perhaps a partial purchase/partial donation can be worked out. Various funding sources were discussed, including grants, public and private donations, etc. Due to the opportunity and urgency of the matter, a meeting is scheduled for next week to meet with Wilma. Update: Society representatives met with Wilma Lathrop on Jan 26 and again expressed to her our desire to purchase her entire collection and reviewed some of her materials. Unfortunately, she has recently sold her Stockton newspaper microfilm collection. (Copies of micro-filmed newspapers are no longer available, so this makes her collection all the more important to us.) She does have the following microfilmed newspapers: El Dorado Springs, Jerico Springs, Lamar, Metz, and Sheldon. Wilma did not initially give us an asking price, so we are attempting to determine a fair and reasonable price and will continue talking with her. Hopefully by the February meeting, we will know what amount of money she feels she would need to have for the collection, and the Society can then make a decision regarding the purchase. Several purchase/donation options were suggested to her in our conversations. She desires to keep the collection together and in this area, as do we.

Additionally, it was approved at the January meeting to nominate Wilma Lathrop for the Missouri State Genealogical Association Award of Merit in recognition of her years of diligent research, transcriptions of records, and other contributions to genealogical research in this region. (Nominations are due June 1.)

- Request from Bonnie Ruebush for obit on Bertha BLISS, d. Sep 19, 1979, and Clarence BLISS d. Apr 4, 1961. Obit located and mailed.
- Received e-mail with photo from a Dorothy, asking for help in identifying the location of the photo. Solicited help with identifying it, and the Historical Society responded that it was on the Vernon Co Courthouse lawn by the Stone monument; I forwarded this info to Dorothy.
- Received request from Michaele Burris asking for 1900-1905 city directory look-up on Henry Jacob BURRIS who farmed in the area. Sent 1892 newspaper info on the death of Henry Burris' father and the 1903-04 and 1905 directory information found.
- Follow-up on lookup for LeeAnn Nelson of Willmar, MN, regarding KIRK family in this region. No additional information located.
- Wrote letter to Norma Fritts, Amsterdam, MO, inquiring as to what compiled records transcripttions she currently had available for sale. Responded that she has not done any more than the Bates Co Obituaries of which we have a copy in the Genealogy Room.
- Received letter from the Old Fort Genealogical Society in Ft. Scott, inquiring about publications we have for sale. Referred her to the Vernon Co Historical Society's webpage, mentioned the new cemetery directory being produced, and advised her that in the future we may have some documents for sale.

- Responded to a phone call from Angie Scotten, Nevada. She is looking for someone to conduct research for free; advised her that we charge a fee and money is used to help procure additional resources. Invited her to use the resources available in the Genealogy Room.
- Responded to request from Edwin Thornton, Robinson, KS, for an obit for Doris BALK, d. Oct 2, 1991, a teacher in a county school which he attended. He is conducting research on the country school which he attended in the Frog Holler area near the state line.
- Responded to e-mail request from Janice George inquiring about fees for conducting research for her.
- Received phone message from a Cathy (area code 217) regarding research on the James LOUDERBACK family. Tried numerous times to return her call and the phone was always busy. Sent an e-mail to her with research information and fee schedule.
- Responded to e-mail from a Donna K. requesting information on a Lutheran Church in the area.
- Responded to a letter from Mary Jo Baker, Waldo, OH, requesting information on a death in the State Hospital in 1894. Located information in old funeral home records and provided some general information about the hospital. Advised her that death certificates were not required in Missouri at that time and referred her to Southwest Mental Health, El Dorado Springs, MO, for possible additional information.
- Responded to request from Bev Hartman, Vernon Co, to check the clarity of a specific census page on Ancestry.com. Looked up the census page and responded by phone to her.
- Responded to inquiry from June Henson, Vernon Co, regarding military records. Referred her to both state and federal websites on obtaining military records.
- Responded to letter from Johnita Turner, Oklahoma City, OK, for information on John Ross JACKSON and related families in this area. Conducted numerous searches and sent information from census reports, Missouri Pre-1906 Birth & Death Records, and Cemetery Records.
- Received a second e-mail request from an Eric Franklin, IL, requesting a free lookup when date

of death was not given – advised there is a nominal fee for searches, copying and mailing.

- Responded to e-mail request from a Mary requesting information on how to find a marriage record when the woman's family is from PA and the man's family is from AL. I recommended she search for the family in the census records and see where the older children were born and begin there, ask older living relatives who may have knowledge, conduct internet searches, and perhaps try to work backwards from the area where they died.
- Responded to obituary request from Jim Hartland, Sterling Heights, MI, on William M. HALEY, d. Feb 13, 1957. Obituary mailed.
- Responded to request for obituary on Fred LEETH, d. May 1971. Advised that no newspapers are available here from 1881 when Mary Keys Leeth died. Searched Vernon Co Histories and other resources.
- Conducted an Ancestry.com marriage record search for Marilyn Bond on a Thomas K. LATHROP. My search revealed that the single record which was at Ancestry.com was not her family.
- Received obituary lookup request from Deb (area code 309). Obituary found and faxed from Library.

- Wrote letter to Marlene Moran, confirming her speaking engagement with our Society in February.
- E-mailed the Ozarks Genealogical Society, the Genealogical Society of Central Missouri, and the West Central Missouri Genealogical Society regarding possible speakers at our annual seminar or a monthly meeting. Also e-mailed the Missouri State Genealogical Association and the Missouri State Archives regarding seminar speakers. And lastly, contacted Lyndon Irwin regarding the seminar. Neoma also contacted the University of Missouri Extension Service and the DAR for seminar speakers, and Dorothy contacted the colleges at Fort Scott, Pittsburg, and Joplin regarding seminar or meeting speakers.
