## March 13 Meeting in Nevada Vickie Erwin, Vernon County Circuit Clerk



Vickie Erwin, Vernon County Circuit Clerk will speak to our group at the March 13 meeting. She will address *Preservation of Records and Preparation of Documents for Microfilming.* The Society will be working with the Circuit Clerk's office in preparing the older court records to be microfilmed. It is not

often that we have an opportunity to join in a preservation project of this magnitude and importance. If you have had an opportunity to research in some of these old records, you know that there are treasure mines of "stories" and information, just waiting to be "J. M. B. M\_\_\_, standing and growing on the land of J. B. Ms. Erwin will explain records retention and explain the microfilming project and what is needed to prepare the many documents for microfilming. The program will begin at 10 a.m. at the Nevada Public Library Meeting Room. Entrance is on the south side of the Library at the Museum entrance. The business meeting will follow the program.

# Acquisition of Wilma Lathrop's Genealogical Library

The Society voted to purchase the Wilma Lathrop genealogical collection. To acquire this extensive private collection is a unique opportunity for our Society and this entire region. As researchers, we all know the value of having all of the information in one place, and having it readily available to the general public. Included with this acquisition are the publication and sale rights of all of the documents that Mrs. Lathrop created. A grant application for funds to make this purchase has been prepared and will be

submitted to the Finis M. Moss Charitable Trust this coming week. Additionally, a preservation grant has been applied for from the State of Missouri, which will enable the purchase of acid-free sleeve protectors, binders, etc., needed to prepare the Lathrop collection for the Genealogy Room.
