The more people who help with this project, the sooner we can have these records available for researchers. In case of inclement weather, please listen to the Nevada radio station to ensure the Library is open.

#### War of 1812 Genealogy

The December video program identified what records might be available on those who served in the military during the War of 1812 and where those records could be found. Because this information may be of interest to members who were unable to attend the Dec. meeting, it is summarized here.

Four major kinds of records can be found:

**1. Service Records** include payroll (muster roll), hospital records, lists of prisoners, sometimes includes a description of the soldier, birth date and place of birth.

a) <u>Federal Forces</u>. Federal records are in the National Archives at Washington, DC.

b) <u>State Militia</u>. Militia records are with the individual State and will generally be at the State Archives.

Sometimes a soldier served in both Federal Forces and State Militia; always look both places.

2. Bounty Land Records. After the war, soldiers were given bounty land located in Arkansas, Illinois, and Missouri for their service. Some sold their bounty land benefit; many did move. Land speculators bought up many land warrants. Land bounty warrants

could be cashed in up until 1845, after which a soldier could take government land wherever wanted (not just AR, IL, MO).

**3. Pension Records.** Only if totally disabled did one get a pension. In 1871, after most veterans were deceased, the Government did let any War of 1812 veteran or widow apply for a pension.

To get a **Pension** or **Bounty Lands**, soldier had to file a bunch of papers with names of spouse, children, birth, age, marriage, etc., as well as battles fought in and unit leader. However, application did not require name of parents.

**4. Claims Records.** After the war, a soldier had to go to the Senate or House of Representatives to file a claim. There are published Claims lists in volumes in larger libraries.

What you need to know to get into the Soldier's Name, State, Regiment, records: Company. I.e., 25<sup>th</sup> of TN or name of person ran the regiment (Col Bradley's who Regiments were headed by a Regiment). Colonel. Supposed to have 1,000 men; usually 650 during War of 1812. Regiment divided groups were into 10 called Companies; each Company headed by a Captain. Usually 65 men in a Company. Knowing the State, Regiment, and Company will allow you to find the records.

Go for service records first: Start with the Federal Service Record Index. Look for the Federal Bounty Lands Index. Federal Pension Index with some bounty lands mixed in.

You can then get the records from the NARA, or you may want to hire a researcher in Washington to get the records.

Next, look for State Militia records. Write 3 places in the state: 1) State Archives, 2) State Library, and 3) State Adjutant General. "I'm looking for records/information on \_\_\_\_\_\_ who I suspect served in the State Militia during the War of 1812. What records might you have that would give me information?"

Then you want to correlate information you get with the 1810 and 1820 census to further locate the family.

The soldier may have been a member of the Regular Army, Navy or Marines. Those records are in a separate place.

"National Union Catalogue of Manuscript Collections" (NUCMC); all written documents from the war. Index on the Internet. Look up by location: town, county, and state where he served. You may find War of 1812 records which are not in the National Archives or the State.

Loyalist, Canadians or British. You've got to know the Regiment. Find the regiment by knowing the battle or the battles in which you ancestor may have fought. If you have no idea, then you look in compilations – do search on Google for indexes such as bounty land indexes, etc.

#### **Traditional Order of Naming**

Thanks to Betty Hicks for sharing this information on the traditional order of naming. This was sent to Betty by a genealogy friend. Many of you may already be aware of this, but I could NEVER remember the ORDER. I have a couple of families in which this will be very helpful, especially when trying to ascertain the surname of the Mother of the children. Not infallible, I know, BUT maybe a hint! It was stated that this is the "traditional order" of naming.

- 1st son = father's father
- 2nd son = mother's father

3rd son = father

4th son = father's oldest brother

- 5th son = father's 2nd oldest brother or mother's oldest brother
- 1st dau = mother's mother
- 2nd dau = father's mother
- 3rd dau = mother
- 4th dau = mother's oldest sister
- 5th dau = mother's 2nd oldest sister or father's oldest sister
