We are looking for more information about Augustus C. Baker's family or origin. We know only that he was born in Germany on April 21, 1827 and immigrated in 1838 at the age of 11. He married Rebecca Pryor in Osage Township, Bates County, MO on March 1, 1849. Rebecca Pryor Baker was his second wife. We would like to know who his first wife was.

We know nothing of Rebecca Pryor's family of origin except she was born on Feb. 10, 1830 and she may have been orphaned.

Daughter Emma Ann Baker was born 1852, and married Archibald **WHITE** circa 1870.

Daughter Mary Elizabeth BAKER was born 1855, and married S. B. **FERGUSON**.

We are looking for pictures of the Augustus Baker Homestead in Vernon Co, MO and of the Riggins and Baker Store in Fort Scott, KS.

We are also looking for pictures of the Samuel Shackelford home probably located on Osage and Native Road near the Center School Northeast of Fort Scott, KS.

We would like to hear from Weyand Family relatives who have ancestors buried in the Coleman Cemetery near the Missouri-Kansas line, west of Vernon County Road 100 (aka Osage Rd, Bourbon Co, KS.) (Editor's note: Marriage Index info: Emma A. Baker married Granville Miller Feb 6, 1868, Vernon Co, Marriage Record Book A, p. 106. Emma Miller married

Archibald G. White Aug 25, 1870, Vernon Co, Marriage Record A, p. 185. Mary E. Baker married Thomas B. Ferguson Oct 25, 1870, Vernon Co Marriage Record A, p. 188. Three different federal and state census mailed to them.)
