Schell City Ledger, Schell City Times and Walker Herald Newspaper Microfilm

The Schell City Ledger, Schell City Times, and Walker Herald newspaper microfilm is now available in the Nevada Library Genealogy Dept. Our Society purchased the nine rolls of film from the Missouri Newspaper Archives in Columbia. Each of these three newspapers were weekly papers and are no longer being published. The dates of the microfilmed issues are as follows:

Deepwood Cemetery

Deepwood Cemetery was recently surveyed by Marty Patton in preparation for the new cemetery directory. She prepared a finding aid of Deepwood, and a copy has been placed in the Nevada Library Genealogy Dept. There are <u>many</u> additional burials from the late 1800s and early 1900s that were not in the previous cemetery directory. (*Thank you, Marty!*)

There are more than 45,500 burials in new cemetery directory being prepared, and only 6 cemetery surveys yet to be completed.

A Big Fire at Moundville The Walker Herald, Thursday, March 10, 1910

The little town of Moundville, situated in the southwest part of this county suffered the most disastrous fire in its history Wednesday night of last week. The origin of the fire is unknown.

The fire was discovered in the rear of the Granay drug store by some boys who were returning home from Prof. Miles' residence where they had been practicing for a play. They immediately gave the alarm but before fire fighters could be organized the entire building was in flames.

The drug store occupied one of the store rooms of the Odd Fellow building, a frame structure. The other room was occupied by the Hammond hardware store, which moved in its stock only a few days ago. The second story of the building was used by the Odd Fellows for a lodge room. The building and both stocks of merchandise were destroyed.

From the Odd Fellow building the flames spread to the Donaldson undertaking rooms, which were destroyed. Most of the stock, however was saved.

The wind carried the fire across the street north to the old drug store building owned by Albert Campbell, which was burned. It was not occupied.

The Woodman building occupied by the Mathews general merchandise store on the first floor and the M. W. A., as a lodge room on the second floor, caught next and was destroyed, together with its contents.

The Williams blacksmith shop was in the path of the flames and met the same fate as the other buildings.

The fire next spread to the Butterfield hardware store and the Butterfield lumber yard which were burned.

All of the buildings destroyed were frame structures.

The citizens had hard work saving the residences of James Fitz Patrick, Prof. Miles, W. J. Butterfield, John Donaldson, J. F. Mathews, W. A. McAllister and others. These all adjoin the business section, which was destroyed. Time after time, sparks from the burning buildings would alight on the roofs, and tiny flames spring up, but the alert fire fighters were always on hand with buckets of water or wet blankets to extinguish the blaze.

The residences of J. F. Mathews and W. J. Butterfield were probably damaged the most. Mr. Butterfield's adjoined the lumber yard where the heat was intense. Several holes were burned in the roof and all the windows broken from one side of W. J. Butterfield's residence.

Following is the estimated damage:

Granary Drug Store, \$2,900; insurance \$2,000.

Hammond Hardware Store \$3,000; insurance \$700.

Odd Fellows, building and regalia, \$3,700; insurance \$2,000.

Donaldson, building \$250.

Gampbell, (sic) building, \$800.

Mathews, stock, \$8,000; insurance \$1,000.

Woodmen, regalia \$300; insurance \$200.

Woodmen and Mathews, building \$1,500.

Williams blacksmith shop \$100.

Butterfield store and lumber stock \$12,000; building and lumber sheds, \$2,000, no insurance.

The damage to the residence property was light.

Vernon County 1855-1900 Circuit Court Records Project

Linda Myers, Missouri State Archives, was in Nevada on Aug. 10 and instructed members on the next phase of the court records project, which is checking each case file against the index and record books to determine/verify the term of court. Additional index books and boxes of files will be moved from the courthouse to the library so that more than two people can work on the project at one time. For this work, volunteers can schedule to work on days other than Fridays. If the meeting room is available, work can be done there or at any other available table or desk in the Library. Please sign in as previously done to record the number of hours worked, and the work schedule sheets are on the storage box.

This phase of the project will go much faster than the first phase, which took two years and eight months!! The more volunteers we have scheduled during the week, the faster it will go. Members of the Elizabeth Carey Chapter of DAR have pledged support, and the local 4-H organization has been contacted regarding volunteers.

Cedar County Probate Files

Zodiac, Montevallo Twp, Vernon Co, MO ZODIAC.

The springs bearing this name are located in the southeast corner of the township (sw. cor. sw. sec. 35), on Horse creek. There is a hotel here and a good bath house, and the locality, though not advertised largely, is liberally frequented during the warm seasons. A town was regularly laid off here in September, 1881, by Moses Isenhower. The site is romantic and picturesque, and lovers of beautiful natural scenery are delighted with the views here presented.

Got His Piktur in the Paper

In a three column feature article in the Kansas City Star of Sunday Zodiac gets more publicity than that village has enjoyed in three decades.

"For forty years the pioneer booster has sat in the ruins and waited to see his dream city rise," says the head line in referring to S. F. Taylor. Most of the article is devoted to Sam Taylor, and incidently (sic) the oil situation is touched upon. The story is illustrated with several views of the ruins of the stone buildings erected there when Zodiac was confidently expected to become the country's leading health resort, a hope which Taylor yet holds unimpaired.

Quoting Taylor the story says in part: "The day will come as sure as fate when Zodiac will be the most noted health resort in the whole United States. When this country is opened up the new-comers will be sure to need a city where they can go for pleasure and health. Why, even one of the springs has an oily taste. Even now I get letters from people all over the country, people who were here years ago, twenty-five asking what accomodations (sic)Zodiac has to offer. They want to come and take the waters. And I have to write and tell them they will have to bring their own accommodations along with them if they want any. There is no place here for them to stay, unless they bring tents. Sheldon is our closest town to the railroad. The road is long and rough and hard for invalids.

"Today there ought to be twenty thousand people here, and there would have been if the place had been property managed. A company of men from Lamar bought Isenhour out and they were going to develop the town. All they ever did was to build a little frame bathhouse. Lots in town sold as high as \$100, but the promoters got to fighting among themselves. They didn't give the people an exactly fair chance, and they killed what hopes the town had. But, in the face of everything, it

was hard to ruin Zodiac. At one time we had two hundred people here."

He pointed to a vine covered stone ruin.

"That was the hotel. Many the time I have had to put shakedowns on the floor for the guests. They came from all over the United States, I tell you. Isenhour was going to enlarge the place until it would cover about a whole block. My wife and I were the proprietors of the Zodiac House, and we did a fine business. My money went into lots. I bought every lot I could, and I've held on. I'm going to keep on holding tight. My wife sticks here with me. Zodiac is bound to be the best health resort on earth."

The Sheldon Enterprise, Sheldon, MO. Friday, August 17, 1917

J. W. Harbert in commenting on an article in last week's issue relative to Zodiac says that while the statement regarding early conditions there was correct, he should have been given credit for establishing the first dry goods store in that burg. "I went there from Lamar in 1885," said Mr. Harbert, "and put on sale the first stock of dry goods ever opened there. There was a small grocery store there at the time, but aside from that mine was Zodiac's first business establishment.
