New Vernon County Cemetery Directory

Work continues on the new cemetery directory, with only five cemeteries remaining

to be surveyed. It is hoped that volunteers will be able to complete the surveys within the next couple of weeks. Once

these last surveys are completed, that data will be input into the database; and then the final formatting will be done in preparation of sending the directory to the printer (est. completion date is now spring 2008).

Volunteers have been diligently working for four years on this project, and they report that there are numerous changes, additions, and previously unrecorded pioneer burials that will be included in the new directory. *It will have more than 46,000 entries and an every-name index.* Watch the website and newsletters for information on purchasing the new directory.

Our member, Linda Davis, 5 Barnet Ave, Waterville, ME 04901, provides the following information on her research:

I am looking for dates and locations of death for the following ancestors:

James White, and his wife, Julia White, were both born about 1820 in Ireland and immigrated to the U.S. The last census I can find them on is that of 1870 in Athens, Bradford Co, PA.

Their son, Bartholomew W. (B. W. or Ben) White was born about 1837 in Bradford Co, PA. His wife was Ellen (Nellie) Golden, and she was born about 1833 in Ireland. They were listed in the 1880 Iola, Allen Co, KS census and then on the 1900 census in Osage Twp, Vernon Co, MO. He worked as a coal miner. I cannot find them in the census after this date or in the state death certificates.

Family stories say they were buried at the Rich Hill Catholic Cemetery but that their graves were lost in road construction.

If anyone has information on this family or suggestions on finding the dates of death, please contact Linda.

Cedar County Probate Files Project

The Cedar Co. Probate Project continues with the workday being Thursdays from 10 a.m.— 3:00 p.m. in the County Commission Room of the Courthouse at Stockton. File packets are being opened, cleaned, flattened, put into folders, and labeled. If you can help with this project on Thursdays, please come to the Stockton courthouse.

Vernon County 1855-1900 Circuit Court Records Project

Volunteers continue their weekly workshops at the Nevada Library to process court case files. More than 37 of the 104 boxes have been completed in this phase of verifying the term of court for each case. There are still some schedule openings for additional volunteers if you can help — contact the society to get started.

The next phase of this project will be to arrange all of the case files by term of court and then box and number them. Once this is done, an extensive index will be typed and made available to researchers.

The files will then be microfilmed, and the microfilm and index will be available to researchers at the Nevada Library Genealogy Department.

Index to Missouri Military Pensioners 1883

Another new book, title above, has been donated to the Nevada Library Genealogy Dept. by a Tri-County member. The following excerpts were taken from the Introduction and How to Use this Index pages of the book.

"In response to a U.S. Senate Resolution dated Dec. 8, 1882, W. W. Dudley, Commissioner of Pensions, compiled a list of all citizens who were receiving a pension from the federal government as of Jan. 1, 1883.

The list included not only the aged, infirm or handicapped veterans of the War of 1812, the Mexican War and Union veterans of the Civil War, but also showed names of dependent widows, children or parents to whom the pension transferred in cases in which the soldier had died."

"This is an index to the Missouri section of List of Pensioners...was arranged by county of residence. This index makes it possible to search the entire Missouri section at once for any pensioners name."

Marie Concannon was the compiler of this index, and it was published by the State Historical Society of Missouri, Columbia, 1997. This addition to the Genealogy Dept.'s military research resources will be processed and available for use within the next few days.

The Society recently purchased copies of the Missouri Gazetteer for both the Nevada Library Genealogy Dept. and the El Dorado Springs Library. Additionally it purchased Confederate Organizations, Officers and Posts 1861-1865 Missouri Units from the Ozarks Genealogical Society.

Please submit your suggestions for additional acquisitions for the library collections.

NARA Lecture

Items of Interest from Area Newspapers

[Each of the below newspaper articles was transcribed by members from microfilm at the Nevada Public Library Genealogy Department.]

A substantial marble monument has been bought to be erected at the grave of the late Rev. Wm. Rider in Fair View cemetery, by his many friends and admirers. Parson Rider, as he was familiarly called, was a pioneer local

Methodist preacher of anti-bellum times, and through all these many years his ready responses to the many calls on him in times of sorrow, his many comforting exortions have so endeared his memory to the surrounding neighbors that they without consulting his family raised a fund and paid for this memorial. It should be fittingly unveiled and dedicated.

Nevada Daily Mail, Nevada, Vernon County, Missouri. May 6, 1903.

[Fairview-Ryder Cemetery is located just across the Vernon County line in Bates County.]

Died at Lamar

F. C. Schilling received a message yesterday from W. W. Davenport at Lamar that his wife, Mrs. Davenport, died at that place that morning of typhoid fever. Mr. and Mrs. Davenport conducted the steam bakery in East Nevada for several years up to about one year and a half ago, when they went to Lamar.

Narrow Escape from Lightning

W. T. Loyd of south west of town had a narrow escape from death Saturday evening when a bolt of lightning struck within a few feet of where he was milking knocking down both himself and the cow a few feet away. Mr. Loyd was severely shocked but is considering himself extremely fortunate that the result was not much more serious.

Schell City News, Schell City, Vernon County, Missouri. April 13, 1922.

River Highest in 18 Years.

The Osage river was higher here Wednesday morning than at any time since 1904. The water stood about even with the rails all along the railroad grade north of town, and reached the floor of the wagon bridge. A large force of men were required to keep the railroad track in place.

An Old Vernon Claim.

A. C. Orick, traveling salesman for a St. Louis grocery house, was in the city Wednesday. Mr. Orick was associated with our highly esteemed fellow citizen, Col. R. W. McNeil, in the mercantile business at Balltown, before Nevada was a village. At that time Balltown was one of the best trading points in this part of the country, and the firm of McNeil & Orick enjoyed a business of fully \$40,000 a year. They were prosperous until Jim Lane with his band of red legs swooped down upon them and looted their store. Mr. Orick said that a claim is still held against the government by this firm for \$40,000 which is signed by the late notorious Jim Lane himself. The claim may be paid some day, but it takes a long time to adjust such matters with the government.

Nevada Daily Mail, Nevada, Vernon County, Missouri. August 2, 1894.

We are informed by W. B. McDowell that the pool hall will be permanently closed on the evening of May 9th as the license expires at that time. He also informed us that no application would be made for a renewal of the license.
