Rich Hill, Bates Co., MO Library

We frequently receive questions about the Rich Hill Library and specifically whether it has copies of the old, microfilmed Rich Hill newspapers, the Rich Hill Mining Review, and others. A phone call to Dixie Glynn, librarian, provides information that they do not have copies of microfilmed newspapers at Rich Hill but they are available at the Butler Library. They do have an 1883 Rich Hill City Directory and an 1888-1890 Butler/Bates County Directory. Additionally, there is a copy of the Bates County Cemetery Directory. Their hours of operation are:

Tue., Wed. & Thu.: 12 noon - 5 p.m.

Sat.: 11 a.m. – 4 p.m.

The Rich Hill Library is located at 514 E. Walnut Street in Rich Hill (phone 417-395-2291). In exiting U.S. 71 at Rich Hill onto Walnut Street, turn west and go about 3 blocks past the railroad tracks – the Library is on the north side of the road.

Items of Interest from Area Newspapers

[Each of the below newspaper articles was transcribed by society members from microfilm at the Nevada Public Library Genealogy Department.]

HOW THE SCAR CAME. Some of T. Y. Brannock's War Experience.

The scar on T. Y. Brannock's left cheek was made by a minie ball at the Marshall fight, in the Joe Shelby raid, in October 1863. After the fight he rode about 12 miles into the country, and had the ball cut out at Rock Creek church by Dr. Brown. He was afterwards taken prisoner and sent to Gratiot street, and from there to Rock Island, Ill. He remained there about a year, and was released at the close of the war. He went out with Col. Elliot in August 1872, (sic) and immediately became attached to Col. Shanks regiment, and served through Missouri with Gen. Shelby.

"We were in more danger at Rock Island," said Mr. Brannock "than we were in actual service. Almost ever day some one or more of the prisoners were killed. The killing of a prisoner meant promotion hence our constant danger. For a good part of the time we were guarded by a negro soldiers, and they were too mean to think about. We were actually starved. Many a prisoner died of hunger. I actually saw men eating from the slop barrels."

ATTACKED THE POSTMASTER. A War With Sticks at Green Springs. The Spencer Family Assaulted by the Millers— Arrests to Follow.

Postmaster H. J. Spencer, of Green Springs came in this morning besmeared with blood from a gaping scalp wound, above the right temple. He had attempted to move the postoffice fixtures about 6:30 o'clock in the morning, from the Frank Harmon building to that of his own and met with

vigorous and hostile resistance. He came in to swear out warrants against the attacking parties.

This is the story Mr. Spencer related to a MAIL representative:

"I had put up a building about 120 feet from where the postoffice had been kept, and this morning, assisted by my wife and daughter, Lillie, started to move the office from the old building to the new one. My daughter is 19 years old and deputy postmaster. When we had started to work moving the things we were assaulted by A. J. Miller, A. A. Miller, Daisy Miller, Nettie Miller and Andrew Miller, who claimed to own the old building and the fixtures. They attacked us with sticks. My daughter was struck on the right arm and shoulder. In front of the office I was struck with a piece of board, about four inches wide and three feet long, by one of the assailants. They then carried the things back into the office. They claimed we were taking their property. I had not rented the building from them and had no business transactions with them, and Mr. Barkley had told me that the fixtures belonged with the postoffice. I was appointed postmaster at Green Springs in March, 1892, to fill the vacancy caused by the death of W. G. Bird. I have lived in that neighborhood for the past 18 years. The Millers moved there about three years ago from Kansas. When they carried the things back into the old office, I told my daughter to go and take charge of the mail and prepare to send out the morning mail. I don't know whether she was marked by the lick she received or not. After telling my daughter to take charge of the mails I came on to town to swear out warrants against our assailants."

Earlier this year Tri-County purchased microfilm of Vernon County newspapers which we did not have in our collection. Other newspapers from across Missouri were included on one of the rolls of film. Because you may be researching in one of these locations, a list of those additional papers and dates is included here. A copy of this list is also on the microfilm cabinet in the Genealogy Department of the Nevada Library. To request a lookup in any of these papers when

the date is known, please send \$5 for the first item and \$3 for each additional item to the Society. If you are a Civil War history buff, the several newspapers from the Civil War and pre-Civil War time periods may be of particular interest to you.
