## Vernon County 1855-1900 Circuit Court Records Project

The last phase of our portion of the work on the circuit court records project will be completed the week of June 9-13! As your schedule allows, please come to the Library Meeting Room early in the week to help wrap up this project. (We do not anticipate that it will take all week to do this.) The Library is open Mon., Wed., Fri.: 10 a.m. - 6 p.m. and Tue., Thu.: 10 a.m. - 8 p.m.; and you can work at any time.

There are 98 boxes of files and each box is "Box" numbered. and "Folder" were previously written near the top right corner of each case file folder. Our job is for each box of files, write the number of that box on each folder just after "Box" and file then consecutively number each case file folder in the box, beginning with 1, and that number goes after "Folder." This must be done with pencil. Of important note: the case file folders have been sorted by date of court term and must be kept in that order for each box. Easy job...just takes a little time.

Once this is completed, our Field Archivist will begin typing the index and then the files will be microfilmed.

This book proved very useful in understanding legal terms from the court files and has now been catalogued and added to the Genealogy Dept.

## DNA Research in Genealogy

Following up on Eldon Steward's April program on the Steward DNA Project, Derl Barnett shares the following information from an article by James Henderson from the Spring 2008 An Canach newsletter:

Henderson explains that although DNA testing can be confusing, the Henderson Surname DNA Project focuses on what they believe is important to the typical family genealogists. There are many companies jumping into genealogical DNA projects, and he cautions that families should thoroughly research any company they consider using and that some companies cannot deliver what The company that the they promise. Henderson DNA Project uses is Family Tree Some surname DNA projects now DNA. display their DNA results on their surname website for the benefit of researchers, and

some surname DNA projects are teaming with research centers that will additionally use the DNA information with modern genetic profiling, which will help people from around the world trace their roots. The Glasgow Caledonia University in Scotland hopes to build up a genetic map of the clans of Scotland, allowing people to look into their Celtic ancestry.

[Each of the below newspaper articles was transcribed by society members from microfilm at the Nevada Public Library Genealogy Department.]

"Popular Therapeutics" was a semi-monthly journal (newspaper) which was published by Long Brothers & Company, Room 5, Moore Building, Nevada, Missouri in the early 1900s. Sol. L. Long, Editor, terms of subscription (strictly in advance) \$1.00 per year and single copies 10¢. It was "A Journal of the National Association of Suggestive Therapeutics" and for "pioneer thinkers along all lines." Of interesting note is that the "paper will carry no advertisements that are not acceptable to the highest class periodicals." The following two articles are from microfilm of this Journal.

Last evening June 8th the message sent was: "THOSE CONQUER WHO BELIEVE THEY WILL."

#### QUARANTINE ESTABLISHED Against Arthur, Mo., and Yale, Kansas To Prevent Introduction of Smallpox— Prompt Action by Nevada's Mayor.

Proclamation of Quarantine.

Reliable information coming to me that smallpox is prevailing in the towns of Arthur, Mo., and Yale, Kas., I therefore do hereby declare and establish quarantine regulations against said towns, and prohibit any person from coming into or remaining in the City of Nevada, Mo., from either of said towns; and further prohibit any railroad company or other transportation company from bringing anyone from said towns and discharging or leaving them within the corporate limits of the City of Nevada, Mo. or within one mile thereof!

Given under by hand this 13th day of February, 1900.

Geo. Jones of near Balltown, who was in Nevada today, gave the MAIL some additional facts concerning the smallpox situation at Arthur. Mr. Jones was at Arthur yesterday and while there learned something of the cases at that place. There seems to be no question but what the dreaded disease has made its appearance at Arthur, and there is no telling to what extent it may spread. According to what Mr. Jones learned yesterday, a sister of Rolla McAllister recently came to visit him, coming from the Indian Territory, where smallpox is prevalent.

She was first taken sick and many of the neighbors were of the opinion that she had chickenpox. After she recovered Mr. McAllister was taken sick, and yesterday Dr. Allen of Rich Hill pronounced his disease smallpox.

Dr. Allen at once telegraphed to Sheriff Ewing. We not now having a county physician, Sheriff Ewing telegraphed to Judge E. N. Hurst at Panama, instructing him to do what he thought best.

Mr. Jones says many persons have been exposed to the disease, many having visited the McAllister residence.

The McAllisters live at the north end of Arthur near the railroad tracks where many people pass daily.

If the smallpox is in its worse stages there is no telling how many people may break out with the disease and every possible precaution should be taken. Nevadians must look out and take steps to prevent the disease from entering the city.

Mayor Irons and Chief Police Lee Carver are taking steps toward keeping tramps from entering the city and will station two policeman at the depot to keep them on the move. Smallpox is raging in Indian Territory and tramps from that direction have been passing through Nevada every day.

Mayor Irons telephoned to Lamar today, talking with the mayor, and found that there were two cases there, one of which had recovered, and the other in house quarantined and extra police. Thought there was no danger of spreading. Lamar's mayor is considering quarantining against Yale, Kansas. Dr. Churchill says: Inasmuch as the dreadful disease is reported so near our door, I would advise every man, woman and child that has not been vaccinated to do so at once, if so then we need not fear a panic, that would be, if the disease should come to our city. Then there would be no use of any uneasiness with our people. The panic would cause more trouble and more expense would be developed than the cost of vaccinating the entire population of the city.

#### SMALLPOX SITUATION. The Dreaded Disease Exists Both North and South of Nevada. County Officials Have Appealed to the State Board of Health.

The smallpox situation has become quite serious and steps are being taken today by county officials to prevent the disease from reaching Nevada.

It was reported here this morning that 5 cases exist in Arthur, which is only 12 miles north of Nevada.

Chief Police Carver received a telegram this morning from Hannon, a small station near Yale, Kas., which stated that there is now 17 cases of smallpox in Yale, Kas. This place is about 35 miles south of Nevada. Taking into consideration the nearness of these two places to Nevada Mayor Irons has quarantined against both of them.

Prosecuting Attorney Joe Moss and Sheriff Ewing are in communication with the State Board of Health, which board will be asked to investigate the situation and establish a quarantine against all districts wherein smallpox exists.

Sheriff Ewing telephoned this afternoon to Dr. Allen, instructing him to establish a quarantine around the home of the McAllisters at Arthur, and also sent Newt Short to Arthur to care for the family.

Newt Short is the man who took care of the smallpox patients at Nevada some years ago.

Instructions from the State Board of Health are expected tomorrow morning.

## ANDERSON IN FT. SCOTT JAIL Confesses to Have Broken Out of Nevada Jail Last Fall.

FT. SCOTT, Kan., Feb. 11 – Harry Anderson, a confessed member of a gang of horse and harness thieves with a rendezvous in the Indian Territory, near Miami, who was arrested at Joplin, and who has just been brought here on the charge of horse stealing is known at Rockford, Id., by the name of Charles Upton, and he says the authorities there want him. He also confesses having broken out of the Vernon county, Missouri, jail last fall. The Missouri authorities know him as Sherman Wechner.

Six stolen horses, which he was holding at the time of his arrest, have been located. He has a team at Rich Hill, Mo., and a hack at Clinton, Mo. The crime for which he is wanted here is the theft of a horse from a farmer for whom he worked.

On the way between here and Joplin he traded horses four times, and when arrested he had a set of harness that he had stolen the previous night. He came to Kansas with a requisition to keep out of the hands of Missouri authorities, who, he said, "have it in for him."

A few months ago you may have noticed the "new look" when you used the Missouri Death Certificates website...the death certificates are one small part of the entire website, and there are MANY other online resources available.

The Missouri State Archives and the Missouri State Library, in partnership with the State Historical Society of Missouri, are assisting institutions across the state in digitizing their records and placing them online for easy access. The MDHI home page is at http://www.sos.mo.gov/mdh/. The MDHI includes records of enduring historical value from institutions throughout the state. These historical resources, including documents, photographs, maps and other materials of interest, are grouped by general topic. Individual collections are searchable under each topic.
