Dedication of Military Memorial and Rededication of Civil War Burial Plot Balltown Cemetery, Vernon Co, MO Sunday, November 9, 2 p.m.

Honor the Veterans in your family and celebrate your patriotism at the dedication ceremony of a beautiful new black granite Military Memorial at Balltown Cemetery on Sunday afternoon, Nov. 9 at 2 p.m. The recently renovated Civil War G.A.R. lot will also be rededicated at this time. Historic Balltown Cemetery is located 8 miles north of Nevada on U.S. 71 to the Horton exit, then 1 mile west. Coming from the north, it is 8 miles south of Rich Hill to the Horton exit, then 1 mile west.

Balltown is the oldest cemetery in Vernon County, dating from 1838; and it is appropriate that this new memorial be dedicated at this location to all Veterans, all branches of service, whether having served in war or peace. The community is honored with the gift of this memorial to all Veterans and with the planned ceremony.

Schofield. Historian Arnold Historical Society of Kansas, will serve as Master of Ceremonies for the event, which will include participation by Holmes' Brigade Civil War Reenactment Unit Color Guard: Phelps Camp #66 Sons of Union Veterans of the Civil War; Colonel John T. Coffee Camp #1934 Sons of Confederate Veterans; Veterans of Foreign Wars; American Legion; Vietnam Veterans of America: Women's Relief Corps (portrayed by Cottey College students); Nevada JROTC Color Guard; the Parade of the American Soldier; and the Cottey College Wind Ensemble. Bill Martin will sing the National Anthem. and Missouri State Representative Barney Fisher (LTC Marine Corps, Retired) will deliver the dedication address.

There will be special recognition of Veterans in attendance, and Veterans are invited to wear their uniform or a vest, cap, etc., which indicates their unit or branch of service. Families of active duty military will also be recognized. You may bring a tribute to leave at the Memorial to honor your Veteran.

The dedication ceremony is sponsored by the Vernon County Historical Society, Balltown Cemetery Board, and Tri-County Genealogical Society.

Please bring lawn chairs. Portable restrooms will be available.

THE VERNON COUNTY HABEAS CORPUS CASE.

Indictments were found yesterday by the United States grand jury, against Messrs. Wight, McAfee, Doss, Ray and Snow, for obstructing United States process and resisting a United States Marshal, by sueing out, executing and giving legal cognizance to a writ of habeas corpus. Col. Wight is the present Representative from Vernon county. As attorney, he was instrumental in obtaining a writ of habeas corpus to test the legality of arrest of his client made by a Deputy United States Marshal. Judge McAfee is the magistrate who granted the writ and ordered the discharge of the prisoner. Mr. Snow is the father of the person arrested. Mr. Doss is a lawyer who aided Col. Wight, and Mr. Ray is a deputy sheriff who executed the writ. The prisoner was discharged, but re arrested and held to answer by the United States Commissioner.

It is expected the trial of these parties will commence in a day or two. Ewing & Smith for the defence.

The case is an extraordinary one. If the charge be sustained, it will upset all popular notions of the efficacy of the writ of liberty, where Federal authority is concerned.

Numerous instances occurred previous to the war, where, through the interposition of this writ by State magistrates, fugitive slaves in custody of Federal officials were torn from their custody, in acknowledged defiance of law, and thus enabled to escape. Yet no Federal court then undertook to punish State magistrates, lawyers or executive officers for thus resorting to the great writ of liberty to accomplish what was then admitted to be an illegal purpose.

But this case is about to come to trial. What we consider proper comments on an attempt to subvert the writ of liberty, are therefore for the present deferred. Our readers will eagerly watch the progress of the trial.

Livingston has recently made another raid into the Southeastern part of Kansas, and committed the murders and robberies which always accompany a guerrilla invasion. Fort Scott has recently been panic stricken, and news from Humboldt and Allen counties is that the people there are greatly alarmed. Our troops have nearly all been taken away. The bushwhackers are well aware of this fact.— *Republican*.

# From Vernon County.

From a private letter from Nevada, Vernon county, to a gentleman in this city, we are permitted to make the following extracts:

"There is great excitement caused by finding the body of a woman, who had been murdered near the rail road five miles west of this place. We have no idea who she was or who murdered her. \* \* Simon Nelson, a Norwegian coal digger, who had been about Walker for three or four years was taken out of Mr. Huff's house (near the Howard school house), and hanged by some unknown parties. A card pinned on his back, said he belonged to a band of horse-thieves. Those who knew him believe him innocent, and think that parties who held a grudge against him hung him. \* \* Another strange occurrence took place Saturday night last. A man took a horse, saddle and bridle from Ed. Requa's stable. Mr. R. missed them next morning, and tried to get trace by tracking the horse; they recognized the track by some peculiarity of the hoof of the horse; Ed. crossed Drywood on the bridge, and went in the direction of the Bosworth ford, on the Marmaton. Near this place he met an acquaintance riding his horse, who informed him that he caught the horse, with bridle and saddle on that morning, near his premises. They then went to the river, saw where the horse went in, seemed to miss the right crossing—the horse came out where the bank was very steep. Seeing no human tracks they supposed the rider was thrown off and drowned. Procuring drag hooks, they found the body about 15 feet below where the horse came out. It proved to be that of a German who had been in Mr. R's employ some time since, but who had been discharged. He came back, stole the horse, and found a watery grave. \* \* I have another sad occurrence to relate. Saturday night last, Mr. J. M. Clark, who resides on Clear Creek. gave as he thought, a dose of quinine to a sick child. The medicine proved to be morphine, from the effects of which the child died in a few hours.

The county court of Vernon county has offered a reward of one hundred dollars for the capture of Baker, who killed Bennett at Sheldon, not long since.

SHELDON *Enterprise:* "Watch for prairie fires. Ten acres of prairie was burned clean, two miles south of town last night. The grass is very dry and a fire with strong wind might do considerable damage."

P. P. Croy, a young man aged 18 years, committed suicide a few days since by hanging himself in his father's barn at Sheldon, Vernon county. The rash act is supposed to have been prompted by a physical ailments, he having been afflicted with paralysis and fits for a number of years.

#### Killed by Lightning.

NEVADA, Mo., June 16—Peter Klontz, aged 25 years, a prominent farmer and stock raiser of Deerfield township, this county, stepped from his barn during a violent electric storm yesterday and had one foot on the outside when he was struck by lightning and instantly killed. His cap was found fully fifty yards away while his clothes were almost entirely consumed by the flame. The lightning hit him on the top of the head, ran down the right side to his feet, split one shoe in two and burned the flesh to a crisp on the right side of the face and body. His beard was burned to a crisp on the left side and not a single hair was left on the right. He leaves a wife and one child.
