#### FamilySearch Update: 6 million New Indexed Records & 1.4 Million New Images Since January 5, 2009

Familysearch added over 6 million new indexed records and 1.4 million new images since January 5, 2009, to its Record Search pilot (see chart below).

The West Virginia birth, marriage, and death records, and the South Dakota state censuses for 1915 and 1925 are now complete. Many thanks to the thousands of online FamilySearch Indexing volunteers who helped make these wonderful records available. See the chart below for more details. The new records can be searched for free at FamilySearch.org (Click Search Records, then Record Search pilot).

Record Search visitors might also notice the following changes to the pilot site after the latest update.

1. Region map flyover now lists the number of collections in a region

2. Rotate an image clockwise or counterclockwise in the viewer

3. New full screen view in the image viewer

4. Search form now displays the collection being searched

5. Image navigation- moved previous, next

- & go to buttons to the bottom of the page6. Collection list page is now a single
- column
- 7. Image only collections are identified
- 8. Changes to print selected area

## Items of Interest from Area Newspapers

[The below newspaper articles were transcribed by society members.]

JUDGE LYNCH HOLDS COURT IN LAMAR Swift Punishment for a Terrible Crime. The Murderer of Mrs. Joseph Goodley and Her Little Boy Meets His Death at the Hands of a Vigilance Committee. Peace and Quiet Reign, Notwithstanding 1,000 People Were Present. No Noise or Drunkenness in the Crowd. A STATEMENT OF THE CRIME. THE HISTORY OF THE LYNCHING THE CORONER'S INQUEST.

[Excerpts from lengthy detailed articles regarding the Sunday, January 17, 1892 gruesome murder or Mrs. Goodley and her son by Robert Hepler at Kenoma, south of Lamar in Barton County, Missouri.]

"On Monday evening, Sheriff Garrett, fearing that the enraged people of Kenoma would attempt to lynch his prisoner, Helper, he conveyed him to the Missouri Pacific depot in a closed cab, and took him to Nevada, and placed him in jail. Since then he has endeavored to commit suicide in his cell by hanging himself. He tried to do this in the Lamar jail, on Monday last, before he was moved away. The prisoner is still at Nevada, and under a close watch. ..."

#### The Lamar Democrat, Lamar, Missouri Thursday, January 21, 1892.

"At 7 o'clock p.m. on Friday, January 22nd, 150 determined sober men went to Nevada and marched directly to the jail. The officers, among them Sheriff Garrett, were taken by surprise. An attempt was made to hide the prisoner in a smoke house, back of the jail, but some one saw him, and in a few moments, the crowd started with the prisoner for the depot. Not a shot had been fired, scarcely an unkind word had been The crowd was orderly and well said. An attempt was made by the behaved. authorities of Vernon county to recapture the prisoner. The militia was called out, but when they arrived at the depot they learned that the prisoner had been taken to Nassau Junction. The rescuing party then went to Nassau Junction, but the prisoner had been When the midnight train taken to Milo. reached Milo, the prisoner and his guards boarded the train for Lamar. Telegrams announcing these facts had been received by the officers here [Lamar], and fully 500 people had assembled at the depot to note the result. The prisoner was near the front of the crowd, who quietly walked up Pacific street to the northwest corner of the square, and then turned south, as if to go to the Gulf depot, but after going south a few blocks, the crowd right about faced and on arriving at the court house square, entered the west gate and went to an elm tree near the northeast corner of the square..."

[Nassau Junction is located southeast of Nevada (west of Camp Clark), at the junction of railroad tracks to Moundville and tracks to Milo.]

# Crime In Vernon County.

NEVADA, MO., Sept. 16, 1877. EDITOR TRIBUNE:--It will be remembered but a short time ago the Sheriff of this county killed one Boisey in attempting to arrest him on a charge from Allen county, Kansas. On last week the Sheriff of Allen county, Kansas, came over to see our Sheriff, and gave him papers to arrest one George Walton, indicted for incest. Walter has practiced his hellish crime upon his own daughter for eighteen months, and when discovered fled to our county to evade the law of his own State. Sheriff McGinnis found Walton in the neighborhood of Clayton, in the western part of the county, and made the arrest without any trouble, as he knew the Sheriff's reputation for shooting. The Sheriff of Allen county, Kansas, received his

prisoner and started back with him on the night train.

#### ON THE SHOOT.

This morning the Constable of Walker, a station on the M. K. & T. Road, 8 miles east of this place, brought to the jail a man named Lon Porter, charged with assault with intent to kill. Porter is a painter by trade, and resides in Walker. He has a wife. He spends the most of his time in this place. This morning he went out to Walker from here, and when arriving at home his wife told him that one Bryant Thornhill, a cattle dealer of Walker, had made improper proposals to her. Porter armed himself with a navy pistol and started on the hunt for his victims. He met Thornhill at Edmond's drug store and told him what his wife said, drawing his pistol. Thornhill started to run, when Porter fired two shots at him without any fatal results. The Constable of Walker, C. L. Fulkerson, being near by, ordered Porter to desist, who refused, when the Constable covered him with his pistol and told him he would shoot him if he made any effort to resist. Porter then handed his pistol to his wife, who tried to shoot Thornhill. The general impression is that it was a trumped up charge against Thornhill.

When Porter was placed in jail, your correspondent went inside with the sheriff and learned the following: On yesterday Mr. McGinnis noticed that something was wrong; not saying anything, he took a position so he could see through a window and not be seen on the inside. He had not long to wait, for Bob Virgar, the road agent, went to work on the iron bars with a saw in the cage over the sewer of the jail. The sheriff went to the door and opened it and demanded the tool, but they were too guick and had hit it. He told them that they would receive nothing but water for a ration until he got possession of it. One of the weak ones squealed, and he found it in the bowl of the sewer. It had been made from a truss worn by one Jackson. The ring leaders he gave a hearty supper of water and locked them in their cell; repeated the ration this morning, but the "water was

good." We asked the birds for what their feathers were plucked? The nine responded as follows: Dan Edwards for stealing 40 acres of land by deeding it to parties in Kansas; Peter Doyl and Joe Everman for hanging Simson Nelson last spring; Bob and Bill Virgar for bull-dozing Coyner two weeks ago out of \$30.00; old man Jackson for cohabiting with his step-daughter; Big John for converting his neighbors mules into; Joe Huffman for dealing with cattle without any capital invested, and Porter whose case I have given, constitute the happy family in our county jail.

The crops here are all the farmers could ask for. Thousands of bushels of flax and castor beans are being shipped daily. The largest acreage of what ever sown in this county is being put in this year. PAT

The locomotive and tender broke through the bridge, carrying the engineer along, who was drowned, the fireman and engineer's son saving their lives by jumping. As a result the trains have been more irregular than usual, if such a thing is possible. *Nevada Criterion.*

For the Army Argus. A NEW REGIMENT FOR THE SOUTH.

Capt. Emmet McDonald is now securing volunteers for a regiment of mounted men to support and act with the flying artillery in the service of the Confederate States of America. The term of service to commence immediately and end duly when the enemy is forced from every foot of soil that is sacred to a Southerner. The men will be mounted on fine horses of the best bloods of Kentucky and Tennessee, and uniformed in the most splendid manner. Two companies will be armed with breach loading rifles and pistols. Two with double barrel shot guns and pistols; and two with double barrel shot guns and Polish Lancers. The regiment will be designated the "Saint Louis Legion," and will, when fully organized and complete, be the most efficient corps engaged in the service or the South. No man of disrepuble (sic) character will be allowed to serve in this regiment. To those who wish to win fame for themselves, as well as render efficient aid to their country, we would say man the guns of the Saint Louis Legion and follow where leads our brave and gallant warrior, Gen. Steriina (sic) Price. Χ.
