Vernon Co, MO Marriage Records Name Indexes 1855-1956 Now Online

Name indexes for Vernon Co, MO Marriage Record Books A through W have been placed on our website at www.rootsweb.ancestry.com/~motcogs/

Indexes for Books I through W were completed by some recently tremendous volunteers - thank you! The online indexes contain name and place of residence, marriage book letter and page number for each bride and Researchers wanting a copy of the original marriage record can obtain it by sending \$1 for each record requested along with a stamped, self-addressed envelope to the Vernon Co Recorder of Deeds, 100 W. Cherry St., Nevada, MO 64772 - include the bride or groom's name, book and page number in your request.

Of special interest to researchers is that these indexes contain thousands of records of marriages for people from all over the United States who got married in Vernon Co. If you use ancestry.com in your Vernon Co research, you already know that they have 1855-1916 poorly indexed marriage records with poor quality images from microfilm. Researchers now have easy access to better information and can obtain higher quality copies.

Printed cumulative indexes will be available within the next few months. The printed indexes will additionally contain the date and location of marriage, miscellaneous notes from the record (e.g., bride underage and parents give assent), and the name of the individual performing the marriage. Notations on nationality will also be included as given in the original marriage recording.

Nevada State Hospital #3

Researchers continue to ask numerous questions about finding information on former patients of Nevada State Hospital #3. All suggestions about how to research former patients (and employees) are given on our website at www.rootsweb.ancestry.com/~motcogs/neva da state hosp.htm

Our website additionally provides links to the Jim Baker transcriptions of the 1900 and 1930 U.S. Federal Census for the hospital. Instructions on how to request the medical records of a former patient are given. Contrary to common belief, one does not need to hire a lawyer to request medical records.

Researchers should look in the patient's home town newspaper for notice of death or an obituary. Generally, there will not be an obituary in the Nevada, MO newspapers for a patient at the State Hospital <u>unless</u> that person normally lived in the Nevada or Vernon County area.

The new Vernon Co, MO Cemetery Directory 2010 has information on burials in the Nevada State Hospital #3 Cemetery that are marked on the cemetery's plat map. The cemetery does not have any upright grave markers. Over time, the small flat markers have sunk a few inches and are now covered with grass, but they can usually be found by prodding the top few inches of soil.

If you have information on a patient who died while a patient at the Nevada State Hospital #3, we would be glad to add it to the cemetery database to be included in the next edition of the Cemetery Directory.
