# **RESEARCHING YOUR CIVIL WAR ANCESTORS PROGRAM BY GARY AYRES**

The April program will be presented by Gary Ayers, Commander, John T. Coffee Camp #1934, Missouri Sons of Confederate Veterans. This program will include information on how to research your Civil War ancestors. Also see the related Civil War articles below.

The meeting and program are open to the public, and everyone with an interest in local history or researching his or her family's history is invited to attend.

### The Civil War 150<sup>th</sup> Anniversary Commemoration

According to history books, the Civil War began on April 12, 1861 with the attack on Fort Sumter in South Carolina. But in Vernon County, the Civil War actually began in December 1858 with John Brown's infamous plundering, murderous raid into the county and the killing of old Mr. Cruise, a lawabiding pioneer settler.

The Civil War, or the War of the Rebellion as many know it, continues to hold a great fascination for many genealogists and historians. Everyone researching this important period in our country's history (regardless of his/her sympathies) can now have access to Civil War records which have been placed online by the National Archives and Ancestry.com. ### Family Search Adds Records at Amazingly Fast Pace

Of note are a couple of collections which may be of interest to you in your Civil War research: 27,874 digital images - Missouri, Confederate Pension Applications and Soldiers Home Applications. These records are digital images of documents in the pension files and the applications. The applications are arranged alphabetically by name. ### New ID Requirements for Obtaining Copies of Missouri Vital Records

The Missouri health department has adopted new guidelines for obtaining copies of birth, death, marriage and divorce records to help protect Missourians from identify theft. As of March 2011, identification will be required when requesting vital records from the State health department in Jefferson City and local health departments throughout Missouri. ### Member's Research ~ Bigham Family

Member Howard B. has shared some information about his ancestor, Vance Bigham. A reference to Bigham is found on page 813 in the 1887 History of Vernon Co, but merely states that a man named Bigham and his wife died about 1847 in Drywood Twp, Section 7.

Vance Bigham was born between 1802-06 in TN. In 1828 he married Mary Alexander in Lawrence Co, AL. In late 1830 or early 1831, the Bigham family moved to Bates Co, MO (area would have been Johnson Co at that time). Between 1833 and 1843, he farmed land in Rives Co. In 1843 Bigham received two land patents in Henry Co. Sometime after this, the Vance Bigham family moved to Bates (Vernon) Co. In the book <u>Early Deaths</u> of Missouri, it is reported that Vance Bigham died in 1851. Family story also is that he died and was buried in Vernon Co.

Vance and Mary Bigham's son David M. Bigham obtained a land patent in Section 2 of Moundville Twp, Vernon Co in 1856.

## A DARING ROBBERY.

NEVADA, MO., March 3.-The boldest robbery every committed in this city took place in broad daylight this morning. At 7 o'clock Tate Brady, head clerk at W. F. Lewis's shoe store, on the west side of the square, had just opened up and was making a fire when a stranger entered the store, saying he wished to look at a pair of shoes and that he was in a great hurry. The clerk displayed several pairs. A three-dollar-anda-half pair was decided on by the customer, who produced a ten-dollar bill, saying it was the smallest amount he had. Brady was compelled to go to the safe to get the change, but before doing so put his revolver in his pocket. Just as the safe was opened the man made a grab at the money, at the same time pressing a revolver at the clerk's head and ordering him to throw up his hands. Brady jumped to one side and drew his revolver, when the robber fired, the ball passed through Brady's left ear. The shot was returned without effect, and after considerable scuffling, resulting in Brady being beaten on the head with the robber's revolver, the robber decamped, having secured only a five-dollar bill. The remainder of the money had been scattered over the floor in the scuffle. Brady's wounds are of a serious nature, but will not prove fatal. The daring robber has not yet been captured.

### Deliberate Murder—Remarkable Coolness of the Murderer.

From the Nevada (Mo.) Times. July 14. On Wednesday last a man arrived at Balltown, and put up at the Hotel kept by Mr. Pennington. He appeared to be a very guiet man, was riding a splendid horse, and wore a brace of revolvers. He talked very little to any one, but made some casual inquiries about a man by the name of Bedford. On Thursday he was absent all day, returned in the evening, and Wednesday he made arrangements to have his horse taken care of two or three days; but in a short time he changed his mind, got his horse, fired off and cleaned up his pistols, and said he would take a ride. While riding along, Layton, who did the shooting, was overtaken by one of the citizens of Osage, who was going to Marsh Owens' house, where they were threshing and they wheat, got into conversation. When they came to Owens' lane, Layton asked the neighbor, "Is this the road we go?" The gentleman answered, "That is according to where you want to go." Layton said, "Oh, anywhere, not particular." They rode down the lane to near the house, got off their horses and hitched them to the fence, and got over into the yard where the thresher was at work. Immediately after crossing the fence Layton began pulling off the glove of his right hand with his teeth and walking toward the machine, which was still at the time. When within about thirty steps of Bedford, Bedford saw him, turned and ran. Layton drew his pistol and fired, the first shot dropping him. Bedford arose and started again, when another shot brought him to the ground; then Layton stepped up to him and put another ball through him as he lay on the ground. Bedford was shot through the thigh, through the bowels from back to front, and

through the chest from back to front, penetrating the lungs. After firing the third shot, and seeing his victim lying helpless before him with the blood running from his mouth, he turned and walked to his horse, mounted, and leisurely cantered out to the mouth of the lane, and then walked his horse until out of sight. Layton never spoke a word after crossing the fence, but did his work coolly and deliberately.

## SHOOTIN AFFRAY

Sedalia, Mo., Oct. 2.—A special to the Daily Bazoo from Osceola, St. Clair county, this evening, contains an account of the shooting of a desperado named Wm. Sanders alias Red Bill, by the City Marshall of that place. The officer attempted to arrest him, when he resisted and drew his pistol. The Marshall then shot him with a doublebarrel shot gun, the charge entering his breast above the right nipple, killing him instantly. The officer gave himself up to the Sheriff.

#### Liberty Tribune, Liberty, MO. Oct. 4, 1872.

David C. Parks was arrested near Park's Grove, St. Clair county, Mo., on Monday last, by Wm. M. Cox, sheriff of that county, and taken to Sedalia. Parks is charged with being the leader of a gang who robbed the Wells Fargo & Co.'s money safe in Calaveras county, Cal., in August 1876, securing about \$800. His whereabouts were made known through one of his confederates lately arrested.

### An Old Citizen of Audrain County, Mo.

From the Mexico Leader, March 31st.

Mr. Joel Haines committed suicide on the 6<sup>th</sup> inst., at the home of his son William, in Vernon county, by cutting his throat. Mr. Haines was one of the earliest settlers of this county and upon the organization in '37 or '38, was appointed to the office of circuit and county clerk. In 1840, he was elected to the same office, which he held till 1842; when the offices were separated. He was then elected circuit clerk, Judge Morris being elected County Clerk. In 1844, he again became a candidate for circuit clerk, and was beaten by our fellow townsman, Judge J. P. Clark. In 1846 Mr. Haines was elected Sheriff, and in 1850 he was elected to the office of assessor. In 1856 he was Mr. Silas Wilson's opponent for the office of circuit clerk and was again defeated. He moved to Mercer county in 1859 and resided there until about four years ago, when he took up residence with his son William in Vernon county. Mr. Haines was over eighty years of age at the time of his death. No sense was assigned for taking his life except weariness of life. Mr. Haines has probably held more offices in this county than any other man. He bore a high reputation in the neighborhood

and has many friends here who will regret to hear of his death.

A SHOCKING TRAGEDY A SHERIFF AND HIS AID KILLED

-----

From the Bolivar (Missouri) Sentinel, 6<sup>th</sup>.— The Grand Jury of the county of Cedar having found an indictment for murder against two men named Stow and Earnest, a capias was placed in the hand of Capt. John Paynter, Sheriff of the county, to arrest them. The Sheriff having summoned six men to assist him in making the arrest, proceeded about 12 miles from Stockton, on the Osceola road, when they came to the house in which Stow was. The Sheriff and two of his assistants entered the house and found Stow in bed: he then went to the foot of the bed and laying his hands on Stow said: "I am the Sheriff of Cedar county, you are my prisoner." At that instant Stow fired, the ball entering Capt. Paynter's heart, killing him instantly. Lieut. Harvel, one of the men summoned to assist Paynter, was standing at his back, when Stow fired, a second time, killed Harvel. Mr. Noble, another of the aids who was in the room at the time, fired three times at Stow but without effect.

A party of men supposed to be friends of Stow, were seen approaching the house, which had been guarded outside by the remainder of the aids; following to the excitement occasioned by the killing of the Sheriff and Lieut. Harvel, Stow made his escape about an hour afterwards; the house containing some two or three doorways.

Capt. Paynter was an active businessman, and was much esteemed by his fellow citizens. He formerly belonged to the 7<sup>th</sup> Missouri Cavalry Volunteers.
