Items of Interest from Area Newspapers

[The below newspaper articles were transcribed by society members.]

Dedication of McKill Chapel.

Bishop E. R. Hendrix, of Kansas City, will dedicate the new church, McKill chapel, five miles west of Bronaugh on the Moundville circuit, M. E. church, south, the third Sunday in June, the 16th inst., which also is the time of the third quarterly meeting of south circuit, Rev. J. King, presiding elder, and Rev. J. A. Greening, pastor. A basket dinner on the ground. Services 11 a.m. and 3 p.m. on Sunday. Preaching Saturday at 11 and at night. The bishop will preach at Bronaugh Sunday night. A general invitation is extended to all.

Southwest Mail, Nevada, Missouri June 7, 1899.

There was quite a novelty in town last Monday in the form of a portable engine which furnishes its own locomotion, horses being needed only to guide it. The rear wheels supporting the boiler have an inside cog gear connecting with the motive machinery, and the engine moves along drawing whatever is attached without any draft on the team whatever. The engine worked here Monday belongs to parties in Barton county and is to be used in wheat threshing.

Vernon County Democrat, Nevada, Missouri. July 2, 1880

ED. DEMOCRAT:--Please allow me to correct a false, and I fear malicious report, circulating in this part of the county to the effect that I have withdrawn my name as a candidate for assessor, and to state to my friends and the public that my name will stand as at present, subject to the county convention, until August 9th shall declare myself or a better man the choice of the people. I believe the gentlemen aspiring to nomination as myself too the same honorable and highminded to stoop to the littleness of the above.

Last Thursday the dwelling house of Phelps Reed, at Walker, a two-story frame building was burned to the ground in spite of all efforts to save it. All the household goods, however, were saved, and the house was insured for \$600. It is supposed the fire originated from the kitchen stove.

72 YEARS OF NEVADA NEWSPAPER HISTORY

1866—Nevada City Times, first newspaper in Vernon county. R. C. Brown editor. Brown sold to Robert Alexander, who in turn sold to William Crockett.

- Name changed to Vernon County Democrat.
- 1872—W. J. Stone bought half-interest in Vernon County Democrat; name changed to Living Democrat.
- 1878—Nat G. Barter established The Nevada Ledger, first Republican newspaper in Nevada.
- 1880—W. J. Stone retired; Living Democrat renamed Vernon County Democrat.
- 1881—Daily Democrat established; first daily in Nevada.
- 1883—Daily Mail established by R. B. Speed and Wm. J. Knott.
- 1886—Nevada Noticer established by R. W. Crockett and L. H. McDaniel.
- 1888—William M. Bumbarger and W. L. Driggs bought Vernon County Democrat. Driggs sold to E. E. Bean.
- 1888—Harry L. Swan and Wm. V. Herrick bought The Nevada Ledger. Name changed to Vernon County Republican; made it daily and weekly.
- 1890—J. M. McAnulty bought Vernon County Republican; soon discontinued daily.
- 1893—Bumbarger sold interest in Vernon County Democrat to M. H. Grady. Grady retired that year and E. E. Bean became sole owner. Name changed to Weekly Post.
- 1895—E. E. Bean sold Weekly Post to R. W. Mitchell and associates.
- 1898—O. W. Neff and W. F. Crigler purchased The Vernon County Republican.
- 1899—Name of Vernon County Republican changed to The Nevada Herald.
- 1902—Vernon County Democrat equipment sold by H. E. Smith, then owner, to Postmaster Frank Arnold of Lamar and moved out of town.
- 1912—W. L. Earp and J. H. Bean purchased Daily Mail from E. E. Bean.
- 1918—W. L. Earp and J. H. Bean purchased Evening Post; consolidated Daily and Post; name changed to The Nevada Daily Mail and The Evening Post.

1934—Nevada News, free tabloid-size weekly, established by Paul W. Yancey, Jr.

1936—E. M. Crigler, son of W. F. Crigler, who passed away in 1931, purchased O. W. Neff's interest in The Herald and is present publisher.

CATTLE DISEASE SWEPT THE COUNTY IN 1866

In the spring of 1866 there was a malady among cattle. Many men of Vernon county lost all their herds with this disease, which came to be known as Texas fever. Matters came to such a pass that armed men were stationed on the borders of the counties and certain townships to turn back all herds of cattle coming from Texas or the Indian territory.

The legislature passed a stringent law on the subject and in May, 1866, the Vernon county court appointed cattle commissions for each township.

Some herds were encountered in the southern part of the county, having run the gauntlet through Jasper and Barton counties. and were turned back with difficulty. In some cases bloodshed was prevented only firmness by and forebearance the the on part of commissioners.
