A daughter born to Mr. and Mrs. Will Sears, Mon. evening, Mar. 7, 1881. 3:1 Judges Cresap and McGovney are holding court this week; Judge Thornton not having returned from Texas. 3:1

Mr. J. S. Naudain, of Montgomery Co, IL, is at present stopping at Walker Station, with a view to finding a location in Vernon. 3:2

The friends of Charlie Graves, one of our leading citizens, will be pained to learn that he is to be hung on next Wed. night. May the Lord have mercy on his poor soul. 3:2

Max Roos, a teacher in the public school at Hermann, this state, is in jail at that place, charged with having outraged a twelve year old pupil named Emile Bauman, an orphan. 3:2

Work on the L.&S. road between this place and Carthage is progressing rapidly, and we are told the road will be completed to Lamar, about half way, by the first of May. 3:2

Only a few short weeks intervene before the Rockwood House will be thrown open to the traveling public. 3:2

Will Sears reports he has a 10-lb daughter; mother and child doing well. 3:2

Lewis Van Osdell met with an accident this morning that came very near costing him his life. He is an employee of the Stone Mills, and going into the upper story to clean up, his clothing caught in the running gear and he was whirled around at a fearful rate, receiving an ugly wound in the left breast and several severe bruises. Mr. Van Osdell is a most excellent young man, and we are glad to know his wounds are not dangerous. He was taking part in the play of Queen Esther and his services will be sadly missed. From Mr. C. O. Graves we learn that Mr. Ward will take his place in the play. 3:2

Judge H. B. Cresap sold to Bryant Thornhill, of Walker, one day last week 36 head of

beef cattle at \$50 per head. Also a lot of hogs at \$4.50 her hundred. 3:3

State Journal: Last Fri. a number of miners went to Gallager Station, Johnson Co, and began to drink heavily. One of them drank 12 glasses in quick succession and then tapped it off with the contents of a half-pint flask. He was placed in a wagon and the crowd started home. One the way two of the miners turned the man on his face and played cards on his back. When they arrived at the mine the drunken miner was found to be dead. 3:3
