#### **Net Neutrality**

Under the Federal Communications Commission's net neutrality rules, broadband companies were forbidden from slowing down or blocking connections to content. That prohibition was struck down by the D.C. Circuit Court last month, enabling companies to legally slow service if they chose. Verizon suggested in oral argument last fall that it was interested in different service models.

This is important to us as private citizens and genealogists – internet providers could lower our internet speed when accessing certain websites. Please take the time to become familiar with this issue and contact both your State and Federal Senators and Representatives and urge support of net neutrality.

#### Indexing 1876 and 1886 Vernon County, Mo. Maps

The Bushwhacker Museum is organizing volunteers to create indexes for the 1876 and the 1886 Vernon County maps. These indexes will be very helpful for researchers. Genealogists pass it forward...we index records here and, in return, other genealogists index records in locations where our ancestors lived. Anyone wanting to help with this project can contact Will Tollerton at the Museum, 667-9602, and he will explain how it will be done. You can work at the Museum or take a township map page home to type.

#### FamilySearch Indexing Website

FamilySearch recently released a newly redesigned indexing website at <a href="https://familysearch.org/indexing/">https://familysearch.org/indexing/</a> to make indexing records easier. Training and detailed information explain "how to." Volunteers select a project from the list of about 200 items. In 2014, there is a special project focus to index millions of obituaries. Volunteers index small batches of records at a time, on-line, on their home computers. Most batches can be completed within 30 minutes. Indexing records to help make them available without charge on the internet is a great way to support the genealogy community.

## Vernon County Probate Microfilm

The genealogy society has several new rolls of probate microfilm which also needs to be indexed. This is a very easy indexing project but must be done at the Nevada Library Genealogy Dept. in order to use a microfilm machine. I have indexed a few rolls of this film to see exactly what is involved and how long it takes. **This is very easy to do.** A roll of film is loaded onto the microfilm machine and advanced to the beginning of the first probate file. The (1) image number, (2) first and middle name, (3) surname and (4) film number are typed into a spreadsheet. The film is advanced to the next probate file and the image number and name are typed. Because the microfilm roll number is the same for all files on that roll, it is typed one time and copied-down for the entire roll.

It averages about 90 minutes to index a roll. It is okay to stop in the middle of a roll and complete it later, because the image number tells you image location of the last file indexed. A laptop computer will be stored at the library for this indexing project, and a typing table will be placed at the second microfilm machine. Please contact me if you would like to work on this project, and we will meet at the library to get started.

#### Training

When the weather warms up, we will schedule several computer research sessions and work days at the Nevada Library...it is still just too cold!

Our next assessor, Petty, was at Nevada last week, engaged in the hand-shaking business.

Eureka Letter. Eureka Springs, Ark., June 20. Long article telling the advantages of Eureka Springs, its many springs and their healing powers...There are many of your acquaintances here, among them Senator Lloyd, proprietor of the Ponce de Leon, a magnificent hotel in North End, Rev. John Hale, Mr. Veatch, Mr. Copeland and wife, Samuel Perrine, Mr. Ellis and wife and Miss Sallie Presley, Tom Meyers and wife, Sam Lancaster, and a party of ladies I have not yet seen and others of Vernon, a number from Cedar, Barton and Bates counties. Those above mentioned, except Messrs. Meyers and Lancaster, parties I have seen today, all claim to be better. Mr. Ellis' case is that of paralysis. He came here totally blind but now claims he sees a very little. Miss Sallie Presley has had sore eyes for years and was almost blink. Her eyes now look sound, there being no inflammation, but you can see they are weak. I don't believe half the people who come use the water as they should. I will venture to say that any person who has drunk one gallon a day will say there is virtue in the water. There has been a great many deaths, generally invalids, a great many have measles. I advise leaving children away until late in the summers or fall. Board from \$3 to \$7 per week. Quid Nunc. 2:6
