Cherokee members set to retrace Trail of Tears

TAHELQUAH, Okla. (AP) - Nineteen Cherokee Indians are set to begin an annual 950-mile bicycle ride from Georgia to Oklahoma to commemorate the forced removal of Cherokees from the southeastern United States to Indian Territory, now known as Oklahoma. Members of the Eastern Band of Cherokee Indians and the Cherokee Nation of Oklahoma who are making the "Remember the Removal" ride gathered Friday in Cherokee, North Carolina, before leaving for Georgia for the start of the journey Sunday. An estimated 4,000 of the approximately 16,000 Cherokees died of exposure, starvation and disease during the removal, known as the Trail of Tears, tribal officials said.

Riders will make stops at museums, gravesites, stockades, churches and other historic sites along the way, accompanied by Cherokee Nation tribal council member and Trail of Tears historian Jack Baker. The riders will also document their journey using personal video diaries. The ride follows the northern route of the Trail of Tears. It begins Sunday in New Echota, Georgia, and is to end June 19 in Tahlequah, Oklahoma, the capital of the Cherokee Nation. The riders will cross Georgia, Tennessee, Kentucky, Illinois, Missouri and Arkansas before ending the journey in eastern Oklahoma.

SON OF POSTMASTER STEALS \$5000 PACKAGE

Confession Follows His Capture After a Long Chase Through Southern States.

NEVADA, Mo., April 11. — Edward Griffith, son of the postmaster of Great Bend, Kans., has been arrested here, charged with having stolen a registered package of \$5000, which was sent by the Traders' Bank of Kansas City to a banking house at Great Bend on February 9. Griffith confessed.

Griffith was once an employe of the Great Bend postoffice and had access to the registered packages. After taking the \$5000 he fled to El Paso. Tex. A letter in the Nevada postoffice addressed to "Ed Graham," known as Griffith's alias, led to his arrest. An inspector went to El Paso and trailed Griffith to Carthage, Mo., and from there to Nevada, where Griffith came to meet a woman, to whom he had given a large part of the money. The woman turned the money over to the Inspector and her name was not divulged.

NEVADA, Mo., Aug. 20. — Five persons were killed at Minden, a station on a branch of the Missouri Pacific Railroad, this afternoon by the explosion of a car of dynamite. The dead: Station Agent Brooks, wife and daughter of Minden; Engineer Rodea and Fireman Todd, both of Nevada. A train crew on a local freight was switching some cars, when they struck a car of dynamite.

TWELVE YEARS IN JAIL IS MURDERER'S SENTENCE

Physician Who Killed Farmer in Missouri Last May Sent to the Penitentiary. NEVADA, Mo., Dec. 24. — Dr. J. T. Todd, a practicing physician and a former member of the State Legislature, who shot R. T. Wall at Richards, Mo., in May last, was found guilty of murder in the second degree by a jury here to-day and his punishment fixed at twelve years in the State penitentiary. Todd pleaded self-defense. Ill feeling had existed between the two men for twenty years. Wall was a wealthy farmer.

PRAIRIE FIRE RAGES.

Missouri Farmers Lose Their Crops Through a Man's Carelessness.

ST. LOUIS, Mo., Oct. 30.— A special to the Chronicle from Nevada, Mo., says: One of the largest fires in years has broken out in Montevallo Township. Four hundred acres of heavy timber and 300 acres of corn have been destroyed. The losses will reach several thousand dollars. Hundreds of people are fighting the flames. A man near Harwood carelessly threw a burning match on the ground, and the fire that it started burned four farmers' crops, amounting to 125 acres of corn and meadows before it could be checked.

KANSAS CITY, Mo., Dec. 19.--On account of the tremendous rainfall in Missouri railway traffic has been seriously disrupted. All trains on the Missouri, Kansas and Texas north of Sedalia have been abandoned, long stretches of track being under water. At Rich Hill the Maries des Cygnes River is out of its banks, and great damage is feared. Nevada, Mo., reports the Maratonn [Marmaton] River higher than for four years past, and rising eight inches an hour. At Jefferson City a tenfoot rise in the Missouri has occurred, while the Osage and Gasconade are higher than for years.
