#### **Digitized Nevada, MO Newspapers**

Just a reminder from last month's article regarding online, digitized local newspapers. Not all of the Nevada newspapers are on the googlenews website, and some that are on that site have had some articles randomly erased. If you are not finding what you need and issues are missing for a specific date, please contact the Society. I will do a few lookups for long-distance members as I have time, at no charge.

#### **DAR On-line Lineages in Genealogy Research**

We have probably all utilized the wonderful online, free DAR "Genealogical Research System" in our research. It is important to understand that what you see online is not an approved, verified lineage. When a woman submits a DAR application through a chapter, her lineage may not be entirely complete or correct when submitted – perhaps a fact is not satisfactorily proven, only a partial date is given for an event, the maiden name of a spouse is unknown, etc. As a DAR application is processed, it will be "marked-up" with edits to correct it. What you see online is not the marked-up lineage; however, a copy of the marked-up lineage can be ordered from the DAR for \$10 when using a credit card online. A copy of genealogical proof used in applications can also be ordered from the DAR Library. If you have questions regarding this, please contact me and I can help you get answers.

#### **Quarters for Microfilm Machine**

A hint from one of our members: If you are printing several documents from microfilm and run out of quarters and the Library staff does not have change, you can walk across the street to the carwash in front of the library – they have a coin changer which takes both \$1 and \$5 bills. #### **Purchase of New Microfilm Machine**

The Nevada Library has purchased a new ScanPro microfilm scanner machine. With this equipment, virtually unreadable microfilm can be corrected to make it readable, and newspaper pictures can be satisfactorily obtained. The digital file created in using this equipment is saved to your personal flash drive, but you cannot print directly from the ScanPro equipment. You print from your flash drive at another computer or save the digital file for future use. The viewing screen is a vertical computer monitor. Once this equipment has been installed, we will schedule training for members. This is a fantastic piece of equipment to add to the Genealogy Dept.—some members saw a demonstration of a ScanPro several months ago. *Again, Nevada Library, thank you, thank you!!* 

It is anticipated that the new equipment can be placed on the stand where the older machine now sits. The older microfilm machine (which no longer prints) can be moved to the brown table along the north wall where patrons only needing to view film can use it.

BALLTOWN, Mo. – An eight-pound cannon ball, relic of the Civil War, has been plowed up on the farm of W. H. Hallett by Ernie Cole, the tenant, reviving tales of the past action near here when union forces under General Pleasanton engaged Confederate troops led by General Price and General Marmaduke. The cannon ball was given to the Vernon County Historical Society.

#### Identified.

The horses taken in by Sheriff Asher last week, in the possessions of Mercer, were yesterday identified by their owners. The black pony belonged to J. Blazely, of Balltown, Mo., and the bay horse to J. L. Brand, of Rich Hill, Mo. The owners took their horses home, and the sheriff of Vernon county Mo., will get a requisition for Mercer, as he refused to go without one. The sheriff received \$50 for his capture. Horse-thieves are almost certain to be caught if they come within Asher's district, as many a thief has discovered.

#### Down an Embankment.

Nevada, Mo., June 28th.— A Missouri Pacific passenger train was wrecked five miles from here this afternoon by the spreading of the rails on a sharp curve. Three coaches were precipitated down an embankment; Conductor Sam Jones and a child of W. H. Marvins, both of Kansas City, were fatally hurt. Twenty-seven other people were injured more or less seriously, but it is not thought that any of them will die.

#### The Madstone Again.

Nevada, Mo., June 16. — Miss Rosa Roach of Pawnee, Kans., has arrived here to have a madstone applied to a wound inflicted by a dog supposed to be affected with hydrophobia. The unfortunate young lady was bitten on the evening of June 12, at Fort Scott, where she was attending a teacher's institute. The same dog attacked other ladies, tearing their clothing, but doing no other damage. The stone adhered several hours.

#### Ten Years for a Robber.

NEVADA, Mo., Dec. 5.— The first trial of train robbers in this State since the passage of the law inflicting the death penalty on this class of criminals was ended here last night, when the jury in the case of W. B. Morris, one of three robbers who held up the Missouri Pacific freight train at Nassau Junction, January 15 last, brought in a verdict giving him ten years.

#### SAME OLD STORY.

#### One Woman Who Was Evil Between Two Jealous Men.

Nevada, Mo., May 19. — A terrible tragedy was enacted at Rhinehart [Rinehart], a small hamlet, fifteen miles northwest of this place, this morning. William Perdue shot and killed A. W. Rundle, set fire to Rundle's house and then shot and killed himself. Rundle received five buckshot in his head. Perdue's intimacy with Rundle's wife, which has existed more than a year, was the cause of the crime. San Francisco Call, San Francisco, California; Sunday, 20 May 1894.

#### **Ex-Bank Officials Indicted.**

Nevada (Mo.), Dec. 12.—At the request of Prosecuting Attorney Scott, Judge Stratton ordered a new Grand Jury impaneled to take the place of the one just discharged, asserting that the latter did not do its duty in not indicting certain officials of the defunct Citizens' Bank, which failed recently under peculiar circumstances. The new jury returned true bills against the President, Vice-President, Cashier and Directors of the bank.

#### Death of L. W. Walker.

SANTA ROSA, July 27.— A dispatch was received here announcing the death this morning, at Nevada, Mo., of L. W. Walker of "The Olives," near Santa Rosa. He was a prominent pioneer and Mason and 78 years old. He went East some time ago to benefit his health. He was a native of Vermont. The remains will be brought here for interment.

#### **Speed Charged With Illegally Retaining Fees**

NEVADA, Mo., Oct. 12. —Attorney General Crow today instituted suit here asking for judgment for \$11,500 against R. B. Speed, former coal oil inspector of St. Louis, which amount plaintiff asserts was collected during Speed's term and withheld by him, in violation of the act passed by the legislature of 1899 defining the compensation of oil inspectors.

#### **HEAVY HAILSTONES.**

#### Hail as Large as Hen's Eggs and Many Persons Bruised.

Springfield, Mo., April 10th.— The severest hailstorm in ten years raged here yesterday. Windows were broken by the hundreds and hailstones as large as hen's eggs fell. Many persons received severe bruises. A cyclone is reported to have passed over Nevada, Mo., and Sandoyal, Kas., last night. Several buildings were blown down. Nobody is reported killed.

#### **Lightning Struck a Mill.**

NEVADA, Mo., Aug. 9. — Lightning struck the big four-story mill of Graves & Ambrose at 3 o'clock this afternoon, damaging it badly and felling five men at work on the lower floor. Two of the men, James Perry and Thomas Jackson, were fatally hurt and the other three seriously injured. Several other persons on the same floor were stunned and shocked, but not dangerously hurt.

#### **An Equine Tanner**

NEVADA, Mo., Oct. 25.—A remarkable case of long life without food or drink developed here yesterday, when a horse supposed to have been stolen from E. T. Letton of this county on the night of September 25 was found alive in one of the stalls at the fair grounds. It had gotten loose from its owner and strayed into the fair grounds, where it was shut in a stall by one of the fair managers, who supposed it belonged to people camped there. When found it had eaten all the pine timber in reach, and though greatly emaciated was able to walk. It had subsisted without food or drink the whole time.

#### A Game Two Could Play.

Nevada, Mo., May 2.— Henry Robinson and George Crane had a rough-and-tumble fight Saturday over election matters in Virgil Township in this county. A warrant was issued for Crane's arrest, and when the Constable attempted to serve it Crane shot him fatally. Another constable was deputized to make the arrest, and in attempting it he shot Crane, inflicting fatal wounds.

#### **Charged With Embezzlement.**

Nevada, Mo. —A charge of embezzlement of \$6000 has been made against Cole Younger, the bandit, by the management of a Wild West show with which Frank James and Younger have been associated since shortly after Younger's pardon from the penitentiary, where he was serving a life sentence. James and Younger had previously brought action for damages against the management because, as they alleged, the show proprietors failed to equip the aggregation according to contract.
