Best Choice UPCs and Labels for Education



Opening the Ozarks: The Legacy of Marsha Hoffman Rising

Marsha Rising spent eight years researching the first 1,000 entrants of federal land at the Springfield, MO Land Office in the late 1830s. This workshop will be presented by Patti Hobbs, CG, at the OGS Library, 534 W. Catalpa, Springfield, on 24 Feb., beginning at 9:30 a.m. Patti will discuss how Marsha's work covers the pioneer families, and also about migration patterns, research methods, and family demographics. The Cedar & Vernon Co MO Genealogical Society obtained a full set of "Opening the Ozarks" a few years ago.

Kentucky Revolutionary War Warrants Database

This database indicates includes 4,748 bounty land warrants issued by Virginia to veterans of the Revolutionary War. Warrants, the first step in land patenting, were given as payment for military services; the allotment was determined by the soldier's rank and time of service, and the land was located in the Revolutionary War Military District. Patents issued for service in the Revolutionary War are filed with the Virginia Patent Series (VA), Old Kentucky Patent Series (OK), and the West of the Tennessee River Military Patent Series (WTRM).

Warrants can be searched by veteran's name, warrant number and immediate assignee. Scanned images from the military warrants register are included for each warrant number. The "authorized" field identifies the patent(s) authorized

by each warrant. If the warrant did not authorize a patent in Virginia's Military District in Kentucky, there is no further information available in the Kentucky Land Office for that warrant. Revolutionary War Allotments

Each state determined its veterans' land allotment. Legislation by the Virginia General Assembly and research by Bockstruck indicates Virginia paid the following bounties for service in the Revolutionary War:

•Sailor or soldier who served 3-yr enlistment or to the end of the War - 100 acres

•Noncommissioned officer who enlisted and served 3-yr enlistment - 200 acres

- •Sailor or soldier who served throughout the War 400 acres
- •Noncommissioned officer who served throughout the War 400 acres
- •Subaltern-Cornet 2000 to 2666 acres
- •Subaltern-Ensign 2000 to 2666 acres
- •Subaltern-Lieutenant 2000 to 2666 acres
- •Surgeon's Mate 2666 to 8000 acres
- •Surgeon 2666 to 8000 acres
- •Chaplain 2666 to 8000 acres
- •Captain 3000 to 4666 acres
- •Major 4000 to 5333 acres
- •Lt. Colonel 4500 to 6666 acres
- •Colonel 5000 to 8888 acres

•Brigadier General - 10,000 acres+

•Major General - 15,000 to 17,500 acres

Where any officer, soldier or sailor fell or died in the service, his heirs or legal representatives were entitled to and received the same quantity of land as would have been due the officer, soldier or sailor, had he been living.

Newspaper Articles of Interest

JOHN HOUSTON (sic) AND WHEN THE "LITTLE TOWN" OF NEVADA BURNED DOWN

The following in Hedda Hopper's Hollywood column, appeared in a recent issue of the Chicago Daily News:

With one roaring success, "The Maltese Falcon," behind him, another starring Bette Davis ("In This Our Life") soon to be released, and "Across the Pacific" in production, John Huston is the directorial hot shot of the Hollywood studies. Yet to see him ambling about the set, you'd think this lanky, unassuming son of Walter was just a visitor gawking at the sights. John dates the start of his career with the day the little town of Nevada, Mo., burned down. John had been appointed fire chief and was half-way through a correspondence course in fire fighting when the holocaust left him out of a job—with the unanimous consent of the citizenry. He did a stretch in the Mexican army, studied art for awhile in Paris, became a professional boxer, meanwhile authoring a play which won him a writing job in Hollywood. Sounds like a pretty crazy preparation for a directing career, but there was nothing crazy about Warners when they grabbed him.

If Heddy's subject was fire chief when "the little town of Nevada burned down" he is a pretty lively "critter" for his age if he is doing what Heddy says. The only time the "little town" was burned down was during the civil war and that was some 77 years ago, counting the year the war closed.

Geo. Hatton, an old negro 95 years of age, residing east of town, claims to have voted the Democratic ticket for 20 years. In the late war George took sides with the southern cause, and was with the noted guerrilla, Bill Anderson, in several hard-fought skirmishes in this section. George was called by Anderson's man, "Bill's high-toned hostler." Anderson always persisted in George wearing a plug hat, and now George takes great pride in exhibiting a weather worn plug, through the crown of which a minnie ball passed during a running fight with Chariton county Militia. George says it was a close call, but he "dodged."— *Rockport Commercial.*

Nevada Noticer, Nevada, Missouri; 25 November 1886

The friends of Mr. Stone in the north part of the district are talking of pushing him for Governor in 1888. We can't spare him from congress so soon. That is his special field. It will be in time to talk about him for Governor in 1892.—Jasper County Democrat.

That sounds very well and no doubt could be easily effected, but Mr. Stone is destined for a position worthier of his great abilities. He is the coming United States Senator. He is young enough to serve as governor, to be sure, and perhaps may, before entering upon the more exalted field of his usefulness, but ultimately the United States Senate chamber will claim him as its own.

Nevada Noticer, Nevada, Missouri; 25 November 1886

Circuit Court.

The grand jury adjourned Saturday after finding eleven indictments among them the following: George Gose for a misdemeanor; Henry Church, grand larceny, a theft of \$32 from John Lovell; Walter Foland, seduction under promise of marriage; H. L. Whaley forging the name of H. Penfield; L. C. Cook, burglarizing the cigar house of S. J. Washburn; Elijah Talent, assault upon Officer Duren; Jacob Bauer, embezzlement of Sousley Bro's. horses.

Sidney Brown, who was fined \$40 at the last term of court and who has been in jail ever since, was fined \$50 and an execution issued against his property.

In the case of M. E. Fairchilds vs. Mary Godard the plaintiff was given judgments on six counts aggregating \$1,171.60 with interest at seven percent and foreclosure.

Nevada Noticer, Nevada, Missouri; 25 November 1886

The result in the Carlisle and Morrison districts shows a carefully matured and skillfully executed plan, which was carried out by capturing the Knights of Labor leaders and distributing Pennsylvania money through them. The fact is obvious and there is no possible doubt that James G. Blaine has succeeded in carrying out the preliminaries of his plan to capture the presidency in 1888. The lesson of the result is too patent to require comment. The administration and the next Congress must unite harmoniously on the definite Democratic policy or lose the country.—*Missouri Republican.*

Nevada Noticer, Nevada, Missouri; 25 November 1886

Released From Imprisonment.

Jefferson City, Nov. 16.—By an order of the United States district court, Judge Copenhaver, a member of the St. Clair county court, was today released from further imprisonment and allowed to go home. He was held for contempt of the United States court for refusing to make a levy to pay interest on some \$300,000 of bonds issued in 1868 for the construction of a railroad, which was never constructed.

Nevada Noticer, Nevada, Missouri; 25 November 1886

Hon. J. H. Hinton, member elect of the State Legislature from Bates county, it is said, will enter the journalistic field after the adjournment of the legislature, having purchased a half interest in the Bates County *Democrat*. We trust the report is true. Men of ability and education are always valuable acquisitions in any profession, and Mr. Hinton is preeminently endowed in both respects. **Nevada Noticer, Nevada, Missouri; 25 November 1886**
