The W. F. Norman Company began operation in 1898 in Nevada, MO. Learn the history of this interesting factory which still operates today with drop hammers, stamping out its famous tin ceiling panels and other products. In addition to learning about the company, Thompson will explain the genealogy research which revealed that William Franklin Norman is her first cousin three times removed.

Proclamation 43C—Extinguishing Title for Indian Lands Between the State of Missouri and the Missouri River

March 28, 1837

By the President of the United States of America A Proclamation

Whereas by an act of Congress of the 7th of June, 1836, it was enacted that when the Indian title to all the lands lying between the State of Missouri and the Missouri River should be extinguished the jurisdiction over said land should be ceded by the said act to the State of Missouri and the western boundary of said State should be then extended to the Missouri River, reserving to the United States the original right of soil in said lands and of disposing of the same; and

Whereas it was in and by the said act provided that the same should not take effect until the President should by proclamation declare that the Indian title to said lands had been extinguished, nor until the State of Missouri should have assented to the provisions of the said act; and

Whereas an act was passed by the general assembly of the State of Missouri on the 16th of December, 1836, expressing the assent of the said State to the provisions of the said act of Congress, a copy of which act of the general assembly, duly authenticated, has been officially communicated to this Government and is now on file in the Department of State:

Now, therefore, I, Martin Van Buren, President of the United States of America, do by this my proclamation declare and make known that the Indian title to all the said lands lying between the State of Missouri and the Missouri River has been extinguished and that the said act of Congress of the 7th of June, 1836, takes effect from the date hereof.

Given under my hand, at the city of Washington, this 28th day of March, A. D. 1837, and of the Independence of the United States of America the sixty-first.

Stole 12 Head of Cattle

Cattle rustling isn't the busy vocation that it once was in these parts, and seldom indeed are Vernon county officers called upon to handle a case of this kind, but such was City Marshall D. F. Jordan's job last Friday.

A couple of young fellows drove a bunch of twelve head of cattle into the pens at the stock yards the previous day. They later sold the stock to Clark & Titsworth, but the stories which the boys told about the cattle failed to ring true, and the purchasers told their suspicions to Mr. Jordan who started to look the two strangers up. He found them down by the M. E. church, South, and they were apparently on their way out of town. At his request they stopped, and to his questions told a rambling story of having purchased the stuff from Henry Brandenburg of several miles south of town.

At Mr. Jordan's request that they go down to Brandenburg's and verify the matter, they got into an auto with apparent readiness, but the stories which they told on the road failed to hang together, and the marshal suggested that they had just as well admit that the cattle were stolen. "Well," one of them finally admitted, "there don't seem to be much chance of making a getaway, and we'll just own up that we did steal them."

Further inquiry brought out the fact that the cattle had been stolen from Jas. Lipscomb of near Liberal. The boys gave their names as Jim and Allen Berry, cousins, aged respectively, twenty-one and twenty-seven years. They drove the cattle here, intending to sell them and return on the proceeds of the sale to their home in Mississippi.

Another cousin, so the boys say, is working for Lipscomb, and as he does the feeding they felt sure the theft would not be discovered for some time. They denied, however, that his cousin had any knowledge of the theft.

As the theft was committed in Barton County Marshal Jordan took the culprits to Lamar, where they waived preliminary hearing in a justice court, and in default of bond were locked up to await the action of the circuit court. They expressed a determination to enter a guilty plea.
