Indexes from the Recorder's Office are now available free online at https://vernonmo.icounty.com/

User Name is **GUEST**, and simply click **Login**. (No password is required and you do not set up an account).

To search, click either Marriage or Index Book (deed index books) in the blue box.

To search **Marriages**, enter a Last Name for a list of all Marriages with that surname; add a given name or first letter to narrow the number of those listed. Remember alternate spellings.

To search in the Deed Index Books, in the **Series** field, use the down arrow to select the year range of the deed book index you want to search. Enter the first letter of the surname in the Search Value field. Click the gray **Search** button. The first index page of surnames beginning with that letter will be shown in the window.

Enlarge/reduce and move from page to page using the controls at the top of the image window.

Some deed books have both a Direct and an Indirect Index. Work with the indexes to learn how to use them.

After you have found the index entries of your person, a copy of the document can be ordered or you can stop by the Recorder's Office to obtain the copy. Genealogy requests are usually fulfilled once a week and as the clerk has time.

For marriage records, mail \$1 for each marriage record (up to 5 in one request), and a self-addressed, first-class stamped, #10 size letter envelope.

For deed records, mail \$2 and a self-addressed, stamped #10 size letter envelope for each deed ordered (many deeds will be 2 pages).

Enclose your name and mailing address, and **also your phone number and email address in case there are questions about your order.** Include the type of record, name(s), book and page number being requested.

Olive St., Nevada, MO. The entrance door is on the southwest corner of the building. DNA Genealogy: The Society is again providing programs to help members work with their DNA test results. In order to tailor future programs to assist you, please send an email to the Society at Cedar.VernonCoMO@centurytel.net with information on which test(s) you have taken or administer and also the name(s) of the testing company used (FTDNA, Ancestry, MyHeritage, 23andMe, and Living DNA). Include information about issues you are experiencing or features you would like to see presented in a program. Each of these companies conducts autosomal (atDNA) tests (sometimes called the Family Finder test) which anyone can take. Additionally, FTDNA offers the Y-DNA male-only test for paternal line, and the mitochondrial (mtDNA) for maternal line only which anyone can take.
