With the focus on Civil War research, members are reminded that the Genealogy Dept has a complete, bound set of "The Confederate Veteran" magazine which was published from 1893 to 1932 in Nashville, TN. The accompanying 3-vol. cumulative index contains the personal names of over 11,000 Confederate soldiers as published in the Confederate Veteran magazine. Each entry lists the volume and page number, and many articles include date and place of birth, date and place of death, and military unit. The magazine primarily contains articles relating to the activities of various local Confederate veterans' organizations and also includes biographical sketches, literary works, and obituaries.

AFTER HER BABIES. Mrs. Ewell Recovers Her Children after More than a Year. A Mother's Love Which Overcame All Obstacles.

At one time, William Ewell and wife were residents of Vernon county, but moved to Colorado. After reaching that state they separated, the wife making her home at Durango.

About fourteen months ago, the husband secured possession of two of the children and sent them to Edward Baughan and wife who live near Deerfield in this county. One of them was a little girl about eleven years of age and the other a boy now about four years old. At the time the children were taken, Mrs. Ewell was at a store and had the little boy with her. She was not aware that her husband was in town, but he was watching her movements and while her back was turned, he took the child and persuading the little girl to accompany him, he sent the children alone to Missouri. The distressed mother did not learn what had become of her children until the little girl wrote her from the home of her uncle, William Goodman, who resides in the northern part of the county. After reaching Missouri, she concluded that she preferred staying with her uncle to a residence of Mr. Baugham's and was nicely cared for during his stay there.

After learning the whereabouts of her children Mrs. Ewing commenced making arrangements to regain possession of them, and arrived in this county a short time since. She left two of her children in Colorado.

Mrs. Ewell's first idea was to obtain the little boy by stealth, but Mr. Goodman advised her to accomplish her purpose by process of law and she did so.

Yesterday a writ of habeas corpus was obtained in the circuit court by Attorney O. O. Hoss and in company with Sheriff Hill and Mr. Goodman, Mrs. Ewell started after her baby. She feared that the little one had forgotten her and the thought troubled her deeply. Her apprehension was without foundation. When the child saw her, he threw up his little arms and ran to her, without a moment's hesitation. He even remembered how she was dressed when he last saw her, and asked what had become of the bird which she had worn on her hat. A happier mother or a more contended child would be difficult to find.

Fined for Fraud.

Reed Rupe, who lives in Lake township, was arrested yesterday by George Lucas, and taken before Judge O. T. Davis on charge of obtaining money under false pretenses. He pleaded guilty to the charge and was fined \$1 and costs, amounting to a little over \$15.

Rupe was charged with raising weight checks in the following manner: Saturday he came to the city with corn, which he succeeded in selling to W. D. Bailey. The corn was weighed by Mr. Nixon and then taken to Mr. Bailey's crib. The check was then raised about 1,000 pounds and presented to A. Bennett, who paid it for Mr. Bailey. Monday it was presented to Mr. Bailey, who made investigation and soon discovered the fraud. The matter was placed in the hands of George Lucas and worked up. Mr. Bailey caught on to the deception and fraud by the merest accident, and says there is no telling how many times he has been duped in the same way. In future he will be more careful in conducting such transactions.

Fine Horse Killed.

H. M. Duck's fine surrey horse became frightened by hearing a band this morning, and in attempting to jump a picket fence, his side was pierced so badly that he had to be shot.

Veterinary surgeon T. B. Howard was called, but the doctor ordered the horse shot as it was too late to do anything for the suffering animal. The horse was a dark bay and was considered a very valuable animal.

FOUND HIS RELATIVES Joe Fryer's Relatives Were All Saved But Their Homes Were Swept Away.

Joe Fryer returned from Kansas City at four o'clock this morning. He brought back with him two of Richard Fryer's children. Mr. and Mrs. Fryer remained with the hope of saving something from their overflowed store, but have little hope of accomplishing anything. The family escaped when the water was four feet in depth but at latest report the flood has almost reached the roof of Mr. Fryer's store house, and it is a two-story building. It is located in Armourdale.

Mr. Fryer says it is impossible to describe the desolation. Some trouble is being experienced from the depredations of thieves. He says one of the looters was knocked out of a skiff by the police. The fellow was caught in some wires, but managed to get loose and grasp a telephone pole.

Mrs. Elizabeth Kellogg, who is Mr. Fryer's youngest sister, was not located, but he learned that she had been seen in a wagon and is doubtless safe.

Mr. Fryer's father also lived in Armourdale. His house, as well as the dwellings of Richard Fryer, Mrs. Patterson and Mrs. Kellogg, all members of the same family, were washed away.
